

City of Clayton Solid Waste Survey Summary



Purpose

After careful consideration, the City of Clayton's Board of Aldermen has determined the City will no longer cover the cost of waste collection services for residents after September 30, 2023. As a way to ensure the City takes a resident-driven approach to decision making ETC Institute administered a short survey on solid waste issues on behalf of the City of Clayton. The survey was designed to gather resident opinions and input on the scope of services for the City's next waste collection contract. The information collected will help the City of Clayton determine the waste collection services to be provided after October 1, 2023.

Background

The City of Clayton's fiscal year begins on October 1 and ends on September 30 the following year. The City of Clayton has adopted and implemented the Fiscal Year 2023 Budget. It is projected that the City will have an operating (General Fund) deficit of \$2.2 million at the end of Fiscal Year 2023. The City will utilize funds from its reserves to balance this deficit. It is currently projected that this trend will continue every year without any substantial changes to service levels of increased revenue. The City has a policy that requires at least 25% of annual operating expenses to always be maintained in reserve. By the end of Fiscal Year 2028, it is projected that the City will drop below this reserve threshold. This would create operational issues and will have a significant impact on the City's credit rating.

Over the past two years, the Board of Alderman has considered multiple ways to reduce expenditures or increase revenue. Waste collection became the focal point of these discussions for multiple reasons:

- The City of Clayton has traditionally covered the cost of trash, recycling, and yard waste collection for all single-family and multi-family residences.
- Clayton is the only city in the St. Louis metro area that covers the cost of rear-yard collection services for single-family and two-family residents.
- Clayton is the only city in the St. Louis metro area that covers the cost of waste collection services for all multi-family properties.
- In FY23, Clayton will spend \$2.2 Million to provide waste collection services for residential properties. This represents over 7% of the City's annual operating expenses.
- The current waste collection contract expires on September 30, 2023, providing an opportunity to competitively bid a new scope of services.
- It is anticipated that the cost of the next waste collection contract will increase due to inflation and the increased cost of labor, fuel, and capital items.

Beginning October 1, 2023, residents in the City of Clayton will be billed directly by the City's chosen waste hauler for waste collection services. This decision should allow the City to balance future budgets and maintain its high level of service without the need for a tax increase in the near future. The City will bid citywide single-family and multi-family waste collection for the next contract and will negotiate competitive rates for trash, recycling, and yard waste removal beginning October 1, 2023. Rates will be

specific to the service provided to the property type. The City does not have the ability to accurate determine future rates prior to the receipt of competitive bids.


This results of this survey will help the City take a resident-driven approach to deciding what scope of services will be included in the next waste collection contract for single-family and two-family units.

Methodology

The survey along with a cover letter and postage-paid return reply envelope were mailed to single-family and two-family residents within the City of Clayton. The sample was addressed based and was designed to ensure an equal distribution of responses were collected across the City. The cover letter explained the purpose of the survey and the survey contained a detailed summary of pertinent background information and an explanation of the choices posed to residents. Residents had the option of completing the paper survey and mailing it back to ETC Institute, or they could complete the survey online at ClaytonTrashSurvey.org.

The goal was to complete a minimum of 400 completed surveys. This goal was far exceeded with a total of 855 responses received. Of the 855 responses that were received, a total of 724 residents fully completed the survey – including two demographic questions. The overall results for the sample of 724 households have a precision of at least +/- 3.6% at the 95% level of confidence.

To ensure single-family and households two-family throughout the City were well represented, Institute geocoded the home address of all respondents to the survey. The map to the right shows the approximate location of survey respondents based on the block location of their home To address. ensure the identity of respondents anonymous, remains location of each completed survey is given as approximate location.

Major Findings

Curbside Trash and Recycling Pickup Versus Rear-Yard Trash and Recycling Pickup

Respondents to the survey were notified that the next decision to be made by the City relates to the scope of services for the next waste collection contract for single-family and two-family units in the City. The survey also informed residents that the City would consider the survey data when determining the next scope of services for waste collection.

Respondents were presented with two options that the City is currently considering related to trash and recycling pickup. The table below was taken directly from the survey instrument mailed to residents; the online survey contained the same table:

Curbside Trash/Recycling Pickup	Rear-Yard Trash/Recycling Pickup
On trash collection days, residents roll the containers to the curb and return them to an area out of view after collection. Special arrangements could be made for those with accessibility needs.	This is the service currently provided to City residents. Trash and recycling containers remain out of view and the waste collection company services the containers at the rear of the property.
Less expensive than rear-yard pickup.	More expensive than curbside pickup due to increased fuel and labor usage.

After reviewing the table above, respondents were asked to select the option that they most prefer. Seventy-four percent (73.7%) of respondents indicated that they prefer the City negotiate a citywide waste collection contract for rear-yard waste collection, only 26.3% of respondents indicated that they preferred the City contract for curbside waste collection.

Yard Waste and Compost Collection


The second survey question asked respondents to indicate if they would prefer the City negotiate a Citywide waste collection contract for standard yard waste and compost collection included in the monthly charge or optional yard waste and compost collection for an additional charge. Knowing that a monthly rate for optional services would be determined through the competitive bidding process 66.9% of respondents indicated they would prefer the City negotiate standard yard waste and compost collection included in the monthly charge, 33.1% of respondents preferred that the City negotiate yard waste and compost collection as an optional charge.






Q1. Should Clayton's next Citywide contract for trash and recycling be for CURBSIDE COLLECTION or REAR-YARD COLLECTION?

Q2. Should yard waste and compost collection be included as part of the regular monthly rate, or should it be optional with an additional charge?






- Standard yard waste and compost collection included in the monthly charge
- Optional yard waste and compost collection for an additional charge


Q3. What is your age?
