COMPREHENSIVE PLAN

This is a resolution for the Board's consideration to endorse and reaffirm the Clayton Tomorrow 2040 Comprehensive Plan as the city plan. By charter, ordinance and state law, the Plan Commission is charged with providing a master plan for the physical development of the City of Clayton. On June 3, 2024, after holding a public hearing, the Plan Commission voted unanimously to adopt Clayton Tomorrow 2040 Comprehensive Plan. As a matter of good practice, staff recommends that the Board of Aldermen passes a resolution endorsing the decision of the Plan Commission.

PROCESS OVERVIEW

The City's general city-wide Master Plan was last updated in 1989 having originally been created in 1975. The City's Business District Master Plan was developed in 1993 and updated in 2010 with adoption of the Downtown Master Plan. The City issued the Request for Proposals for a comprehensive plan in December 2022. A review committee consisting of Plan Commission representatives, the City Manager, Director of Public Works, Director of Economic Development, and Director of Planning and Development Services interviewed four teams. Based on a general consensus, the team of PGAV Planners, WSP, and KSG was awarded the comprehensive plan contract in April 2023.

The first phase of the comprehensive plan process, Understanding Existing Conditions, ran from April through July of 2023. The process began with the first Comprehensive Plan Steering Committee meeting. The Steering Committee included a variety of residents, stakeholders, and staff and met a total of ten times. During the first phase, the consultant team focused on data collection and analysis, identifying strengths and weaknesses, and establishing connections and awareness with the community regarding the comprehensive planning process. Draft Planning and Review was the third phase, running from December 2023 through February 2024. During phase three, the consultants focused on preparing high level recommendations, land use scenario ideas, and identifying priorities. PLAN DOCUMENT OVERVIEW

The Clayton Tomorrow 2040 Comprehensive Plan, Appendix, and Existing Conditions Report can be viewed online at https://engageclayton.com/claytontomorrow2040. The following is a summary of the sections included in the plan document:

1. Introduction & The Process

The first two chapters outline the background of Clayton and introduce the process of a comprehensive plan. A summary of the engagement activities and key themes is also included.

2. Existing Conditions

The third chapter provides a summary of the larger Existing Conditions Report including demographics, land use statistics, and transportation data.

3. Mission & Vision

The existing City of Clayton mission statement is used as an overall guide. Based on the priorities and goals identified by the community throughout the process, seven vision statements were created. The vision statements are broad goals for 2040.

4. Key Objectives

The vision statements are translated into more specific objectives (goals) and key results (tasks and strategies). The objectives are organized into four categories: Housing and Neighborhoods, Commercial Development and the Economy, Community Character, and Transportation and Connectivity. Under each objective is a series of key results that when implemented would result in achieving or significant progress toward the objective. Recommendations include revisions or new regulations, policies, or guidelines as well as areas for additional in-depth study. The plan includes a total of 17 objectives and 71 key results.

5. Future Land Use

The future land use chapter identifies broad use designations for land in Clayton. Land use designations are one of the base elements used to establish zoning districts and become an important way to identify where in the community changes may occur to support implementation of goals. Land use designations include single-family residential, one or two-family residential, multi-family residential, mixed-use, commercial, institutional, park, and greenspace.

6. Character Areas

The future land use map identifies general land use categories, and the character areas chapter goes into more detail by identifying eleven areas of the City and establishing specific development patterns and goals for each. The development patterns identify important connectivity between different areas, land use, building height considerations, density of uses and development, and activity nodes. The character area vision statements and descriptions help translate community priorities for specific areas and determine where a general land use designation, such as commercial, may be different depending on the context of that property.

7. Implementation Matrix

The implementation matrix helps identify where to start and how to proceed through the objectives and key results recommended in the plan. Each key result is identified in the table along with how implementation of the key result would connect to each vision statement, a proposed timeline, a responsible party, and partners. The matrix is a tool for the Board of Aldermen and staff to track progress and identify annual priorities.

8. Appendix

The appendix contains raw data from engagement activities including comments made during in-person events or submitted online and survey results.

NEXT STEPS

Following adoption of the plan, the City will undertake a review of the recommendations. With direction from the Mayor, Board of Aldermen, and City Manager, the City will identify key results for immediate consideration and will engage the associated staff and partners. Staff will also draft an executive summary of the plan along with additional website-based information to help educate the public on the recommendations and track progress on implementation. Additional public engagement will take place associated with specific key results as implementation continues.

STAFF RECOMMENDATION

Staff believes that the Clayton Tomorrow 2040 Comprehensive Plan was prepared with significant public input and is reflective of comments made by various stakeholder groups, commissions, boards, and the public. Staff further believes that the plan will serve the City well into the future and is ready to begin implementation. Staff recommend approval of the resolution as presented.

RESOLUTION 2024-09

A RESOLUTION OF THE CITY OF CLAYTON, MISSOURI ENDORSING THE CLAYTON TOMORROW 2040 COMPREHENSIVE PLAN, AS THE CITY PLAN OF THE CITY OF CLAYTON, MISSOURI

WHEREAS, in 1975 the Clayton Plan Commission adopted, ratified, endorsed and reaffirmed the Clayton Master Plan, as the "city plan" and "zoning plan" of the City of Clayton, Missouri, within the meaning of Section 89.340, et seq., RSMo. and as the "master plan" within the meaning of Article IX, Section 2 of the Clayton City Charter; and

WHEREAS, in 1989, 1993, and 2010 the City of Clayton amended the city plan through adoption of Clayton Business Districts Master Plan and Downtown Clayton Master Plan showing recommendations for the physical development and uses of land; and

WHEREAS, in the years since the original adoption of the city plan and the subsequent amendments, significant changes have occurred that impacted the development of the City of Clayton such as infrastructure improvements, national economic shifts, local turnover in property, and a renewed sense of community interest in the future of Downtown Clayton as well as sustainability and equity initiatives; and

WHEREAS, commencing in April 2023, the City along with PGAV Planners, WSP, and Key Strategic Group embarked on the process of developing a city plan by providing extensive public review and input through public meetings, surveys, presentations, and work sessions; and

WHEREAS, after extensive review and public input, the Clayton Tomorrow 2040 Comprehensive Plan was established in order to provide the City with a vision for future development opportunities, civic improvements, and implementation strategies; and

WHEREAS, this update shall also function as the master plan for the continued development of the City within the meaning of Article IX, Section 2 of the Clayton City Charter;

WHEREAS, the Plan Commission conducted a public hearing with respect to the adoption of the Clayton Tomorrow 2040 Comprehensive Plan on June 3, 2024, after due notice as provided by law and voted to adopt the city plan; and

WHEREAS, the Board of Aldermen conducted a public meeting with respect to the decision of the Plan Commission and the Clayton Tomorrow 2040 Comprehensive Plan on June 11, 2024;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF CLAYTON, MISSOURI, AS FOLLOWS:
