Minutes from the May meeting was approved as written.

<u>Livable Community Master Plan Draft – Goals, Strategies and Actions:</u>

Toni Siering, Director of Parks and Recreation provided a draft update on the Livable Community Master Plan with Goals, Strategies and Actions.

Goal #1: Leverage public space as a platform for gathering and connection.

Enhance the park's design to create a welcoming and inclusive space for people of all ages, abilities, and backgrounds. Use sustainable practices and embrace year-round use of parkland. Identify flexible programming spaces for various activities and partner with local organizations to facilitate the creation of public art in Clayton parks. Expand the park's space strategically to fill gaps in the community.

Goal #2: Make it easy for people of all ages and abilities to walk or ride to their destination.

Improve walking and biking infrastructure for people of all ages and abilities. Invest in sidewalks, safety improvements, and accessibility upgrades. Create a convenient network of bike infrastructure and coordinate with St. Louis County to address safety on roads and intersections. Implement programs and policies to support walking and bicycling and facilitate access to public transportation.

Goal #3: Collaborate to advance Clayton's goals of equity and sustainability and meet needs now and in the future.

Incorporate greening and sustainable practices in public spaces. Expand access to recreation resources through joint agreements and collaborate to provide more educational and enrichment programs for adults. Foster culturally and historically significant narratives in parks from an equity perspective.

Goal #4: Strategically embrace our role as a recreation hub for both the community and the region.

Develop city-managed programs and events to meet residents' interests in arts, food, and cultural programming. Increase usage of recreation programs and facilities, reduce barriers to access, and encourage inclusive use of offerings. Promote high usage of department programs and facilities by commuters and neighboring communities. Develop tools and standards to guide the management of recreation programs and balance operations with revenue generation.

Commission members gave feedback on the strategies and made recommendations for various strategies and clarification of verbiage.

Director's Report:

Toni Siering reported that the contractor for Remembrance Park was able to coordinate a cost-effective solution to an issue with an AT&T line, enabling the project to move forward.

The splash pad at the Treetop playground in Shaw Park has been upgraded with all new equipment and was opened for Memorial weekend.

Ms. Siering reported that the Board of Aldermen approved a lighting study for Shaw Park Tennis Center, Oak Knoll Park, and Shaw Park. An application for a Municipal Park Planning Grant was also approved, which will offset the cost of the study by \$10,000. The lighting study is set to begin shortly and is expected to be a multi-year project.

The YPO Fireworks Show in Shaw Park, sponsored by Barry-Wehmiller last Saturday, was approved by the Fire Department. Ms. Siering stated that additional discussions will take place to address administrative policies related to fireworks events.

The Picnic in the Park event at Shaw Park on June 2nd was a great success.

Old Business / New Business:

Eric Schneider, Parks and Recreation Commission Chair introduced the new Aldermanic Representative on the Parks and Recreation Commission, Jeff Yorg.

An update on the pool cleanliness and lifeguard issue at Shaw Park Aquatic Center will be reviewed at the next Commission meeting.

The meeting was adjourned at 8:00 pm.

LIGHT TO PROTECT THE NIGHT

Five Principles for Responsible Outdoor Lighting





USEFUL



ALL LIGHT SHOULD HAVE A CLEAR PURPOSE

Before installing or replacing a light, determine if light is needed. Consider how the use of light will impact the area, including wildlife and the environment. Consider using reflective paints or self-luminous markers for signs, curbs, and steps to reduce the need for permanently installed outdoor lighting.

TARGETED



LIGHT SHOULD BE DIRECTED ONLY TO WHERE NEEDED

Use shielding and careful aiming to target the direction of the light beam so that it points downward and does not spill beyond where it is needed.

LOW LIGHT LEVELS



LIGHT SHOULD BE NO BRIGHTER THAN NECESSARY

Use the lowest light level required. Be mindful of surface conditions as some surfaces may reflect more light into the night sky than intended.

CONTROLLED



LIGHT SHOULD BE USED ONLY WHEN IT IS USEFUL

Use controls such as timers or motion detectors to ensure that light is available when it is needed, dimmed when possible, and turned off when not needed.







Sample Lighting Management Plan Purpose and Philosophy

1. Purpose and Philosophy

This Lighting Management Plan (LMP) is intended to guide the selection, placement, installation and operation of all new and replacement/retrofitted light in the park. Its function is to regulate the use of artificial light at night (ALAN) in the park in a way that prioritizes the safety of visitors and staff while minimizing the impact of such light on protected outdoor spaces, viewsheds and wildlife. Therefore, all instances of the use of ALAN in the park will adhere to the principle that outdoor light should be deployed only: (1) when it is strictly needed; (2) where it is needed; (3) in the appropriate amount for a specific task; and (4) with the appropriate spectrum.
