Outlined below are the objectives from the Clayton Tomorrow 2040 plan organized by chapter. On the following page, we have identified the key results that staff believe should be the starting place. Under the "Yearly Task Order" column, the key results with a "1" are where we recommend starting for FY25. These are the items in the code that will have the most immediate impact on various development projects that represent priorities from residents. Many of the key results we recommend under FY25 also benefit from the same initial research or analysis. This will allow us to be efficient with staff time. On Friday, we will go through a discussion that outlines what staff expect each FY25 key result to entail and what the end product would be. We hope to gather direction on your priorities from this list so we can make adjustments as needed.

- H 1 Clayton contains a diverse housing stock, providing attainable and quality housing options for a range of ages, income levels, and life stages.
- H 2 Clayton preserves and enhances the unique identity of each neighborhood with relevant and compatible standards.
- H 3 Out neighborhood development patterns embody sustainable principles and seek to minimize impacts on the natural environment and plan for future resilience.
- H 4 People choose to live in Clayton because it is safe and provides convenient access to first-rate schools, services, shopping, dining, parks, and community amenities.
- CE 5 The City maintains a strong economic base by supporting commercial development at a variety of scales.
- CE 6 Clayton promotes vibrant and attractive commercial nodes with creative enhancements to existing corridors.
