National Disability Employment Awareness Month




October is National Disability Employment month, a time to celebrate the value and talent workers with disabilities add to American's workplaces and economy.

## Leading Companies in Disability Inclusion



America's economy is stronger when every American has an opportunity to thrive and contribute meaningfully.



### Disability Rights Advocate: Haben Girma

As the first deafblind graduate of Harvard Law School, Haben Girma is a strong advocate for disability rights, especially focusing on accessibility in the workplace.

She is a leading voice on the importance of inclusive technology, which is a key aspect of ensuring equal employment opportunities for people with disabilities.



### Disability Rights Advocate: Caroline Casey

Caroline Casey is the founder of **The Valuable 500**, a global movement focused on putting disability on the business leadership agenda. The Valuable 500, founded at Davos in 2019, brings together CEOs from multinational corporations to commit to disability inclusion in their companies aiming to influence cultures at the highest levels of business.

The exclusion of people with disabilities is estimated to cost countries up to 7% of their annual GDP, according to the International Labour Organization. According to Casey, business needs to understand "the value, not just the cost" of inclusion.

Caroline is legally blind due to ocular albinism.



### Disability Rights Advocate: Alice Wong

Wong is the founder and Project Coordinator of the Disability Visibility Project, a project collecting oral histories of people with disabilities in the US that is run in coordination with StoryCorps.

She also works the Disabled Writers project, which is a resource to help editors connect with disabled writers and journalists.

She was recently awarded a John D. and Catherine T. MacArthur Foundation fellowship.

Alice Wong was born with spinal muscular atrophy, a neuromuscular disorder. She stopped walking at the age of seven or eight.
