Benjamin Uchitelle Elected Mayor

In April, Ben Uchitelle, who ran unopposed, was elected Mayor of the City of Clayton.

Mayor Uchitelle's service to Clayton is a testament to his dedication to the City and its citizens. He previously served as an alderman, and from 1991 to 1997 as Mayor, leaving office due to term limits. To name just a few highlights during his prior tenure, the City turned a budget deficit of over \$600,000 into an ample operating reserve; and the Clayton Recreation, Sports and Wellness Commission (C.R.S.W.C.) was established to oversee the process of planning and constructing The Center of Clayton. The capital improvements to residential neighborhoods that also occurred during his previous term as mayor served as the catalyst for an upsurge in home renovations and additions.

Mayor Uchitelle and his wife, Susan, have lived in Clayton since 1965. They raised three children, all of whom attended and graduated from Clayton High School. Their son, Elliott, also resides in Clayton with his wife and children. Mayor Uchitelle serves as counsel to Husch & Eppenberger, a major regional law

Clayton Appoints New City Manager

The City of Clayton recently announced the appointment of Michael A.

Schoedel as the new Clayton City Manager, effective June 1, 2004. Mr. Schoedel served as the Richmond Heights City Manager since June 1998, and has overten years of public sector experience working in three different communities. A native of Kirkwood, Missouri, he received his Bachelor's degree from Valparaiso University in 1990 and his Master's degree in public administration from Southern Illinois University at Edwardsville, in 1993.

As Clayton City Manager, Mr. Schoedel will oversee activities of seven different departments with 177 full-time employees, and an annual City budget of over \$26 million.

Mr. Schoedel has an impressive background in public administration and is familiar with many of the issues facing Clayton due to his work on joint city projects. "He has a reputation as an excellent communicator and team-builder, and for his commitment to providing exemplary public services to the communities he serves," said former Mayor Frank Kenney.

Continuing Our Strengths

Thank you for giving me the honor of serving you again as the Mayor of Clayton for the next three years. At the outset, I would say that Clayton overall is in strong shape due to the able work of former Mayor Kenney, our six fine Aldermen, and our dedicated and professional staff of some 180 persons.

A City of distinction is the result of continuing quality efforts by its citizens, by its employees and by its elected officials. Clayton exemplifies those criteria, and as a result, has long been a wonderful place to live, work, or visit.

So what are my goals for the coming years:

- * Working with our new City Manager, Mike Schoedel, to ensure a smooth transition and to support his leadership of the day to day operations of Clayton. Hopefully you will all soon have an opportunity to meet Mike. I think he will bring strength and vibrancy to his position. And on that note, I'd like to personally thank the Acting City Manager Lenore Toser-Aldaz for her excellent leadership during the past nine months. She has done a truly first rate job during a difficult transition period, and we are most pleased Lenore will continue in her job as Assistant City Manager.
- * Working more closely with the Clayton School District. The well-being of our City is dependent upon the continued academic excellence of the Clayton School District, and likewise, the School District depends importantly upon the ongoing strengths of the City. The School District has a number of major upcoming issues, and the role of the City will be to be as supportive as possible in helping to resolve those challenges.
- *Our distinct and vibrant neighborhoods define and enhance our quality of life. Clayton residents are proud to say they live in Wydown Forest or Davis Place or Ellenwood or Old Town or one of our other fine neighborhoods. I want to work hard to strengthen each of these residential areas. That makes good sense and is a key to an overall strong community.
- * MetroLink is coming to Clayton in 2006. In a true sense, this event can have more positive economic impact on our City over the next fifty years than just about any other development. MetroLink will shape the way people come to, view, work, and live in Clayton. So we must be ready to welcome and benefit from MetroLink's arrival. Our intention is to establish a separate Committee of residents, aldermen, staff, school representatives, and business owners to work together over the next several years preparing for, and seeking to assure, the successful arrival of MetroLink in 2006.
- * I want to work hard on economic development. We need to address the recent closings of some of our galleries, retail stores, and also the increasing pressure on our fine restaurants. Competition is increasing from Richmond Heights and the University City Loop area, and this needs to be addressed in a proactive way. So I will work as hard as possible to try to bring about renewed retail and commercial activity in Clayton.
- * One of the important recommendations of our Strategic Issues Committee was to examine personnel matters. Therefore, in the months ahead, we will be taking a hard and new look at overall staff issues. We want to assure that all our employees police, fire, public works, parks, and administration are fairly compensated and benefited within our resources and as compared to our surrounding municipalities. We will be taking a fresh view at this overall situation and making changes as may be necessary or appropriate.
- *Our final challenge will be to continue and increase cooperative efforts between our neighboring communities. Recently the East Central Dispatch Center started operations. The Center handles all police and fire dispatch calls for Clayton, Richmond Heights, Maplewood, Webster Groves and Shrewsbury alike. It is off to a good start with better service and lower cost then was done by Clayton separately in the past. This has been a successful joint effort that has taken a number of years to reach reality. And now I would like to explore with the aldermen other possible cooperative efforts, such as joint trash collection, closer fire service provisioning, and other areas of mutual benefit.

So, there is much to be done to continue to enhance the vibrancy of our City of Clayton. But with the current and very able and dedicated Aldermen, the excellent and highly qualified staff, and certainly our concerned and enlightened citizens, these goals will be realized. Thank you.

Strategic Issues Committee Submits Recommendations

The Strategic Issues Committee, a group of Clayton residents appointed by the Board of Aldermen, recently convened to review the City's current revenue sources, service levels and expenses. The committee was asked to study the current projections and make recommendations to the Board of Aldermen and the Mayor.

On April 23, 2004, the final report with 28 recommendations was submitted. The evaluation was divided into three sections: revenue, expenses and general. The following is a summary, which does not include all recommendations.

REVENUE - Recommendations concerning revenue included: moderately increasing parking fines; increasing court costs in order to cover related expenses; developing a systematic approach to payment in lieu of taxes from tax exempt entities; increasing building permit fees with higher rates for commercial versus residential; and increasing the Special Business District tax assessment to pay for special services needed in the central business district.

EXPENSES - To curb expenses, the committee recommended: outsourcing all or part of the City's fleet services; sending more newsletters and brochures via e-mail; exploring further opportunities for co-op programs with other communities; and examining ways to attract retail and multi-use projects to the central business district.

GENERAL - General recommendations involved: collaborating more closely with the St. Louis County Assessor's Office to get new construction on tax rolls sooner and at the correct value; considering the use of economic incentives to develop more retail opportunities; possibly working with the State legislature to change the Hancock first year assessment rules; modifying the holiday lighting program in the central business district; and aggressively seeking Homeland Security Funds.

The Aldermen and Mayor will study the recommendations and work with staff to implement ones that most favorably impact the City.

The selection of Mr. Schoedel culminates a six-month process, which generated over 110 applications from 26 states, and as far away as Japan. After extensive evaluation, Mr. Schoedel was unanimously identified by the Board as the best candidate to assume the position of City Manager in Clayton.

Mr. Schoedel will succeed Lenore Toser-Aldaz, who served as Acting City Manager following the resignation in September 2003 of former City Manager Scott Randall.

Board of Adjustment: Considers applications for variations to the City's Zoning ordinance.

BOCA Board of Appeals: Hears appeals from property owners regarding the interpretation of the International Building and Fire Codes.

City Plan Commission/Architectural Review Board: Advises the Board of Aldermen on all requests for rezoning, resubdivisions, site plan approval, and conditional use permits. Reviews developments for compatibility with the architectural standards established by the City.

Clayton Art Commission: Supports a process for incorporating artist services and art works into the City of Clayton; defines policies and guidelines for acquiring and commissioning art; and promotes the acquisition, maintenance, and upkeep of works of art on sites within the City.

Clayton Recreation, Sports and Wellness Commission: Oversees the operation of The Center of Clayton, a joint use athletic/recreational facility owned by the City of Clayton and Clayton School District.

Ecology and Environmental Awareness Committee: Develops and supports ecologically sound programs and practices for Clayton's municipal government, the Clayton community and the metropolitan St. Louis region.

Economic Development Advisory Committee: Recommends the use of funds collected within the Special Business District; and makes recommendations regarding significant matters related to the vitality of the Clayton business community.

Housing Council: Assists the City in its continuing efforts to maintain and enhance the City's housing stock.

Industrial Development Authority: Provides tax-exempt financing to eligible industrial and manufacturing facilities in accordance with federal and state tax laws.

Landscape Committee: Develops and implements comprehensive landscaping plans for all City parks, public spaces and right-of-ways.

Non-Uniformed Employees Retirement: Administers the non-uniformed employees' pension plan.

Parks and Recreation Commission: Advises the Board of Aldermen on programs and facilities designed to promote recreational opportunities for all residents of the community.

Strategic Issues Committee: Determines and prioritizes strategic issues with which the City is faced and periodically prepares a strategic plan for the Board of Aldermen.

Uniformed Employees Retirement Board: Administers the uniformed employees' pension plan for sworn Police and Fire personnel.

City Completes Oak Knoll Pond Renovation

Clayton City officials proudly announced the completion of the Oak Knoll Pond renovation project. City staff did the majority of the work because construction bids submitted as a result of the Request for Proposals were over the original \$100,000 budget. Clayton's Public Works Department was asked to serve as general contractor. The Parks & Recreation and Public Works staff collaborated to complete the work. The project which included sidewalk extensions, landscaping, amphitheater repair, installation of a fountain, and a new monument sign was completed within budget. A \$50,000 grant from the Municipal Park Grant Commission helped fund the trail extension, landscaping, and amphitheater repair, while the City's Recreation and Stormwater account covered the balance.



A special event is planned for this fall to celebrate completion of the project and to encourage residents to visit Oak Knoll Park and its new surroundings. Event details will appear in the August issue of CityViews.

Olympic Torch Run Update

On August 13, 2004, summer Olympic Games will begin in Athens, Greece. Prior to the opening of the games, the Olympic Torch will be carried in cities throughout the world. The torch will be carried in only four American cities: Los Angeles, St. Louis, Atlanta, and New York. It will arrive in St. Louis on June 17. The torch run through St. Louis will begin at the Gateway Arch, and will evetually pass through the City of Clayton. The torch is scheduled to enter Clayton at approximately 7:20 p.m. It will go north on Brentwood from Clayton Road, east on Bonhomme and north on Central. On its way east along Forsyth, it will enter Washington University's Francis Field at approximately 7:45 p.m. for a ceremony commemorating the 1904 Olympics. At 8:00 p.m., the torch run will leave Francis Field and go north on Big Bend into University City. The torch run is scheduled to end at the foot of Art Hill at 8:45 p.m.

Board Accepts Gateway Artwork

The Clayton Art Commission seeks to make public art intrinsic to community life in the broadest and most inclusive sense. Through its interaction with organizations like the St. Louis Art Museum, Washington University and the Gateway Foundation, the Art Commission facilitates the installation of temporary and permanent works of art on loan within the City.

Last fall, the Gateway Foundation approached the Clayton Art Commission (CAC) with a proposal to loan the City of Clayton a sculpture by world-renowned artist Fernando Botero. In March, the Commission voted unanimously to recommend to the Board of Aldermen to

accept Gateway's offer. At its April 27 meeting, the Board of Aldermen unanimously approved the loan agreement with Gateway. The sculpture, *Man on a Horse*, will be installed on the median at the intersection of Wydown Boulevard and Hanley Road this fall. In addition to installing, maintaining, preserving and insuring the artwork, the Foundation has agreed to relandscape the portion of the median surrounding the sculpture at no cost to the City.

The 11'6" tall sculpture is typical of Fernando Botero's distinctive style of smooth, rotund shapes, which play on traditional art themes. "The loan of this work is a wonderful addition to the diverse and growing public art collection in Clayton. It raises the bar of excellence within our community, and we are extremely grateful to the Gateway Foundation for providing this opportunity," said Clayton Art Commission Chair Joan Cohen. In conjunction with the installation of the Botero, the Clayton Art Commission will present educational programming related to the sculpture, the artist, and public art in general.
