# **City Hall/Fire Station Update**

The City of Clayton is pleased to announce the completion of its new Fire Station at the northeast corner of Bemiston Avenue and Forsyth Boulevard. On July 27, 2004, Fire Department staff moved into

the new two-story addition to City Hall. The facility has five engine bays, including one with rear access drive-through capabilities for the City's large ladder truck. The station also includes offices and living quarters for staff, as well as a hose drying tower in the back, constructed to double as a fire rescue training facility.



Additionally, the Forsyth side of the station includes a clock tower, with two clocks that automatically maintain the correct time throughout changes to and from daylight savings time.

With the completion of the new Fire Station, work began on remodeling the old portions of the attached building into office space for the City Hall administrative staff. A large part of the first floor was previously the Fire Department engine bays constructed in 1924. The rest of the building undergoing renovation was originally completed in 1931. The restoration project started with the removal of the interior walls and the installation of new HVAC duct work, a fire suppression system, electrical wiring, voice and data cabling and plumbing. Framing and dry wall will be followed by wainscoting and paint. The second floor Council Chambers will remain intact as it was recently renovated; however, it will be cleaned, polished and returned to its pre-construction condition.

Completion of the renovation project is expected to be December of 2004.

# Clayton's 2004-2005 Annual Budget

In late August, City officials finalized the FY 2004-2005 budget. To be sure all stakeholders had an opportunity to provide input, Clayton's Board of Aldermen held four public sessions to discuss the City's financial plans. At its meeting on August 10, 2004, the Board also held a formal public hearing on the proposed budget to allow citizens an opportunity to offer comments and suggestions, and on August 24, the new budget was officially approved.

Based upon the dialogue at the public meetings, the Board of Aldermen recommended that the 2004 City tax rate remain at the current level of \$0.652 per \$100 of assessed valuation, which will result in a total levy of \$4,576,253. The Special Tax District tax rate, which is used to fund appropriate economic development activities in the Central Business District, will also stay at its current rate of \$0.047 per \$100 assessed valuation for a total levy of \$122,388. While the budget provides for higher expenditures than revenues, the City is comfortable in using reserves to cover the almost \$650,000 deficit in the General Fund. The City has worked very hard to maintain responsible reserve balances.

## **News from Ward II**

With a western boundary at Hanley Road, Forest Park Parkway on the north, Clayton Road on the south, and a portion of Fontbonne University's and Concordia Seminary's campuses on the east, Clayton's Ward II enjoys a wonderful mix of residential, academic and commercial/retail. We appreciate this opportunity to fill you in on the latest news from our ward.

- · Construction is underway for a condominium project at the corner of Cromwell Drive and Clayton Road in the Moorlands. The development will include a public green space that will be maintained by the condominium association. Local artist Carol Fleming has proposed two sculptures for the area.
- Phase I of another development will begin soon on Forest Court. This project is a 3-½ story, 15-unit condominium with an exterior that is in keeping with design elements in the rest of the neighborhood. The building will include 30 parking spaces with access off Bemis Way. Phase II on Westwood Drive will begin at a later date.
- And, speaking of parking, the City's 2005 fiscal year budget includes funds to examine the possibility of constructing a multilevel parking lot at the corner of Wydown Boulevard and Hanley Road. The location is currently a City-owned single level parking lot. Maximizing the use of that particular lot will be a real benefit for the bustling retail district in the area.
- The City continues to work with the property owner of the former Schnucks site at the northeast corner of Hanley and Clayton Roads to review possible redevelopment ideas for the site. As soon as a viable and responsible plan is developed, the City will communicate the plan with the residents.
- Ward II contains one of our City's treasures, Oak Knoll Park. The Oak Knoll Park Pond Renovation Project was completed this past spring including improvements to the walking path, amphitheater repairs, enhanced landscaping, installation of a lighted fountain, and a new monument sign. On Monday, September 27, 2004 the City will observe the start of the fall season with a celebration at Oak Knoll Park. The community is invited to enjoy live music, snacks, and fun giveaways. The festivities will take place between 6:00 8:00 P.M.
- Our new sculpture, Man on a Horse, by Fernando Botero, which is being donated to the City by the Gateway Foundation will be arriving soon. Stay tuned for more information on the celebration surrounding the installation.

Ward II is certainly bustling with activity. The pedestrian friendly neighborhoods and commercial areas create a true vibrancy for our community.

## **Transit Center Dedication**

In 2001, St. Louis County started work on the construction of its 1284-space parking garage located at the corner of Shaw Park Drive between Meramec and Central Avenues. The project was completed in Spring 2004, and on July 6, 2004, officials from the City of Clayton and St. Louis County presided over the dedication ceremony for the Shaw Park Drive Garage/Clayton MetroBus Center.

The 416,000 square foot Shaw Park Drive Garage provides seven levels of above-ground parking for St. Louis County employees, jurors and the public.

The Clayton MetroBus Center includes a passenger drop-off area with seven MetroBus stop shelters which include information kiosks and security cameras. Six local MetroBus routes serve this facility approximately every 5 to 10 minutes during the week and every 15 minutes on the weekends. When the MetroLink station, now underway on Forest Park Parkway, is completed in 2006, it will be connected by a passenger walkway to the MetroBus Center.

> Arts in Transit selected Catherine Woods to create artwork for the new facility. Ms. Woods saw the potential to create a soothing spot to stop and relax. She created "Oasis", eight suspended thirteen-foot by three-foot panels. Four are heat strengthened and insulated glass and four are water-jet cut aluminum pierced with abstract designs inspired by symbols of good fortune.

> The project represents a collaboration between St. Louis County, the City of Clayton and Metro, and a benefit to those who work and do business in Clayton.



# **MetroLink Update**

Progress continues on MetroLink construction in Clayton with the replacement of the Central Avenue off-ramp from Forest Park Parkway. Recently, crews demolished the old Central Avenue off-ramp and construction of the replacement is well underway. The new ramp will open when the Forest Park Parkway reopens in 2005.

Three new bridges will be constructed over Hanley Road. Two of the bridges will serve as the new traffic lanes for Forest Park Parkway over Hanley, and the third bridge will be in the median to carry MetroLink. Two pedestrian walkways will be restored with the completion of the project.

A new MetroLink bridge has taken



A new off-ramp from eastbound Forest Park Parkway to Brentwood Boulevard is also underway. Crews will begin building a new ramp from Brentwood Boulevard to westbound Forest Park Parkway. Work will continue on both ramps over the next several months.

An institution in the jewelry business is stepping down. After 60 years of serving the public, Diamond Shop owner Joe Kohn is retiring. Four generations of St. Louisans know and have done business with the affable jewelry expert. The day-to-day business dealings will be passed to Joe's son and daughter-in-law, Thom and Mona Kohn. "Thom and Mona have been involved in the business for decades, and I am confident they will continue providing the quality and good service for which the Diamond Shop is known," stated Mr. Kohn. The Diamond Shop, located at 12 North Central in downtown Clayton, is recognizing Mr. Kohn's farewell celebration with a sale on select items.

# Protzel's Deli Celebrates Its Golden Anniversary

Ron Protzel confirms that things at the Deli have been kept pretty much the way they were back when his mother and father, Evelyn and Bob Protzel, started the business in 1954. "In 50 years, the only thing I've done to change the business . . . about eight years ago, we added counter space and seating," Ron said. Probably the biggest reason the business has been around so long is because it continues to provide fresh and well-prepared products. Bakery items are made fresh daily. Favorites in the deli section are smoked fish, pastrami and corned beef. Protzel's is known for its corned beef, which is prepared from a secret recipe. Mr. Protzel reports that people come from all over the country for the corned beef. A gentlemen from California stops at Protzel's for a few pounds of corned beef on his way to visit his mother in Indiana, and then stops again on his way back home.

Jerry Nicole Parchman, who was adopted by Ron's parents, has worked at the shop for over 35 years. "I'll be here until the walls are torn down," states Mr. Parchman. Ron represents the second generation of Protzels in the business, and now his nephew Max is taking over. "It's a lot about family around here," said Ron. "There have been times when I would be waiting on four generations of the same family."

"The City is proud of the role it played in the history of an institution like Protzel's," said City Manager Mike Schoedel. "We hope that they will be doing business in Clayton for at least another 50 years."

Protzel's will officially celebrate 50 years at its Clayton location during the month of October.

"The proposed budget maintains the extraordinary level of service that has been traditionally provided by the City," confirmed City Manager Mike Schoedel. During the public hearings, expenditures, revenues, real estate assessed valuation and fund balances were reviewed. Major infrastructure improvements associated with the budget, include:

- improvements to the Forest Park Parkway/S. Brentwood Boulevard interchange (MetroLink project) \$1.5 million
- completion of the renovation of City Hall \$730,000
- replacement of City vehicles that are at the end of their life cycle \$475,000
- improvements and repairs in several parks and at the Hanley House \$385,000
- refuse/recycling collection contract increase, as the prior contract expired \$300,000
- parking study to determine feasibility of a parking structure at southeast corner of Hanley Road and Wydown Boulevard \$80,000
- improved signage in the Central Business District \$50,000

An unstable economic environment, rising health care and benefits costs, maintaining high-quality services and regional issues represent concerns for future budget preparation. The City Manager confirms that staff will continue to review activities, identify trends to find cost-savings and other opportunities to improve the City's financial situation, while continuing to provide the high level of services that Clayton residents expect.
