## Clayton Participates in **Hurricane Relief Efforts**

To date, five Clayton Fire Department employees, including Fire Chief Mark Thorp, were called to assist with the hurricane relief efforts: three as part of the Urban Search and Rescue Team and the other two as part of the National Disaster Medical System Response Team. The Clayton Fire Department was also called by the Statewide Mutual Aid Coordinator to provide its emergency supply of Meals Ready to Eat (MRE's) to be shipped to the members of the Missouri Urban Search and Rescue Team.

On September 2, the City hosted an employee luncheon to help raise funds for the hurricane relief efforts. Approximately \$2,100 was raised; \$1,600 donated by Clayton employees and \$500 coming from Clayton on the Park Hotel. The funds were sent to the American Red Cross.

Additionally, the City of Clayton took the lead in coordinating an effort to collect toiletry supplies for hurricane Katrina disaster victims. The City Manager invited Clayton hotel General Managers to the City Hall luncheon and to contribute items to be packaged and shipped to victims of the hurricane.

In early September, a number of Clayton restaurants participated with others from the area in an event in which a percentage of their sales was donated to the Salvation Army and the Marshall Faulk Katrina Relief Fund to assist hurricane disaster victims. Participating Clayton restaurants included: Barcelona Tapas Bar, Barrister's, C. J. Mugg's, Cafe de France, Finale, I Fratellini, J. Buck's, Lampert's Plush Pig BBQ, Remy's Kitchen & Wine Bar and The Ritz-Carlton, St. Louis.

## **City of Clayton Emergency** Readiness Status 2005

The City of Clayton possesses a comprehensive all-hazards Emergency Operations Plan (EOP) that was last revised in late 2004. Predicated on the assumption that Clayton will be on its own for up to seventy-two hours before outside assistance begins to arrive, the plan was designed to address a variety of manmade and natural disasters.

Distributed to elected officials, department heads, and other key city staff, the City's EOP draws on federal, state, and local legislation which provides a legal foundation for the document, one that is additionally supported by various mutual aid agreements among local first responder agencies. Two of the most noteworthy are the Code 1000 plan for law enforcement and the Region C mutual aid agreement for fire and emergency medical services. Adhering to federal requirements, the EOP also adopts the Incident Command System as the primary management system that will be utilized by City personnel.

The EOP is routinely exercised, with joint emergency exercises being conducted in conjunction with the U.S. Secret Service and St. Louis County Police Department in 2004, and Enterprise Rent-a-Car and the Saint Louis Art Fair staff during various dates in 2005.

City personnel have undergone a myriad of emergency training, with Police and Fire Department personnel alone having received hundreds of hours of emergency operations training in the past two years. Topics include the Incident Command System, the National Incident Management System, weapons of mass destruction and anti-terrorism training, among a multitude of other specialized courses.

## From the Desk of the Mayor

A lot is happening in Clayton and I wanted to share with you the challenges and opportunities involving our city at this time.

#### **Increased Real Estate Taxes**

At our August meetings, and after several months of intensive budget analysis, the Board of Aldermen and myself as Mayor unanimously approved an increase in our residential and personal property taxes. This is the first real estate tax increase in over ten years, except for a very small increase several years ago specifically to provide for the hiring of three additional firefighters. The tax increase, coupled with stringent cost control efforts, will assure the continued superb services that Clayton residents have enjoyed for decades and will also help to maintain the conservative balances in our several funds for capital expenditures and replacements. Set forth on Page 3 is information on how taxes will impact you as a property owner.

#### **Clayton and Richmond Heights Merger Study**

The first meeting of the Joint Study Committee (JSC) was held on September 28th. The JSC consists of twenty citizens from Clayton and twenty from Richmond Heights. The Clayton membership reflects a broad range of residents from every part of our city. The study will extend over eighteen months to twenty-four months, and the committee will analyze the advantages and disadvantages of all aspects of the two cities from the standpoint of services, finances, strengths and weaknesses, and then make recommendations to the respective councils of each city for their consideration and action.

It is emphasized that all of the meetings of the JSC are open to the public and will be taking place alternatively at The Center of Clayton and at The Heights. In addition, a separate website has been established which contains continuing updated news, information, meeting schedules and the like on the merger study, and I urge you to visit it on a regular basis. #### **New Downtown Development Matters**

- **Centene Corporation**, a national Medicaid management company headquartered in Clayton, has purchased the entire Library Ltd. property and is proposing a major campus development covering approximately the half block between Forsyth and Carondelet, and bounded on the east by Hanley Road. This will involve the construction of two office towers in a campus type setting with retail elements. It would also involve the purchase of Clayton's parking garage on Carondelet for a significant amount. Our garage is and has been underutilized and its purchase will then place the garage on the tax rolls. In addition, Clayton would continue to have the ability to utilize a number of spaces in the garage for public purposes.

Centene Corporation has requested limited tax abatement of the new development buildings and economic assistance from the State of Missouri because of the approximate 1,000 new jobs it will bring to Clayton as a result of this project. Clayton staff and consultants are actively involved in negotiating this complex project and there will be public hearings on all major aspects as we move forward.

- -Mark Mehlman Realty is proposing a high quality, approximate 70-unit condominium project on Carondelet, east of Hanley and facing the Ritz Carlton Hotel to be called **The Crescent**. The project will involve extensive retail on the first floor in a design that follows the curvature of the street and is architecturally compatible with both the Plaza in Clayton and the Ritz-Carlton Hotel. The project will adopt the City's streetscape found in the central business district and include public art. Construction is expected to begin in December with project completion in 2007. Recently, it was approved unanimously by both the Architectural Review Board and the Board of Aldermen.
- A contract has been signed for a major development on land behind the Ritz Carlton Hotel, mostly within the Clayton boundaries but also a portion in University City. These would be apartments and condominiums and related retail. This is quite preliminary, and there are a number of contingencies, but I would point out that an essential desirability factor to the developer is the proximity to the MetroLink Station directly across from the project.

### **MetroLink Matters**

We continue to be frustrated by the MetroLink construction activity, shutting or limiting roads and blocking access points to our downtown area. And it is only a small consolation to say that this is the necessary imposition of a \$600 million construction project traversing our downtown business area. Yet the plus side is that upon its completion, scheduled for late October of 2006, Clayton should become a major beneficiary of the entire project in a host of direct and indirect ways. On a long-term basis, we believe MetroLink will ensure the continued vitality and regional central point of Clayton for decades to come. Needless to say, our Clayton staff has been working extensively with Metro to minimize and hasten these major construction efforts.

I hope this summary of some of the many activities that Clayton is facing and working on for your benefit is of interest and help to you.

# 2005 Real Estate and Personal Property Tax Rates

On August 23, Clayton's Board of Aldermen adopted the annual budget for Fiscal Year 2006, which included a tax rate increase. The following includes historical graphs of real estate tax rates as well as a breakdown of the estimated additional impact the recently adopted tax rates will have on property owners' tax bills. Please remember that the City of Clayton is only 10% of the total property tax bill. The City is one of several organizations that make up the total property tax rate.

In addition to training, the City has cataloged its available resources for use in the event of an emergency, and has augmented those resources with small caches of emergency provisions, to include food, water, and various medical supplies. Grant money has enabled the City to purchase a variety of equipment to include Class C personal protective environmental suits and other safety gear. Communications systems have been redesigned to improve interoperability, so that not only can City departments operate on common radio channels, but the City's emergency service agencies can readily access multiple mutual aid frequencies.

Emergency preparedness is an ongoing process, and City employees continue to acquire training, review tactics, and coordinate planning efforts with agencies like the State Emergency Management Agency and the St. Louis County Office of Emergency Management. Unfortunately, it is a fact of life that each and every city is inherently vulnerable to a variety of disasters. Yet should the worst occur, the City of Clayton is committed and ready to provide its residents and business community with the most effective, efficient, and professional emergency response and recovery program practical.

Traversing Clayton's residential neighborhoods where trees and bushes are protruding onto sidewalks can be unpleasant and sometimes dangerous. Clayton Building Inspectors will be checking for overgrown landscaping. The City asks property owners to examine their trees and shrubs to be sure they are maintained properly.
