

Part of the charm of living in Clayton is access to wonderful neighborhood boutiques, restaurants, and other businesses. Recently we, as Ward 2 Aldermen, held a Wydown-Hanley merchants meeting at City Hall. Our goal was to continue to facilitate an open dialogue between the merchants and City government with regard to any issues or opportunities that may come up. Some of the topics we discussed were:

• Parking: Business owners have ongoing concerns about parking for their customers and employees. Several ideas were discussed, including the possibility of creating a structured parking lot at the southeast corner of

Wydown and Hanley. Other factors that impact parking are being addressed, such as moving the bus stops to less congested areas, and adjusting the scheduling of delivery trucks and street cleaning to non-peak hours.

• Traffic Safety: Because of the high volume of foot and bicycle traffic at this intersection, the city is always looking for ways to insure safety. Moving the bus stops helped by reducing congestion and increasing visibility. In addition, textured pedestrian crossings will be added next spring. Bicyclists will notice some positive changes as well, as bike racks are installed over the next few weeks, and the Great Rivers Greenway bike path is marked with banners and signage.

• Wydown Fall Festival: A

charming festival will highlight the area for residents and passersby on October 7th from 10:00 a.m. to 1:00 p.m.. This celebration features our businesses and has something for everyone, including a small art show, music, snacks and drinks, and activities and prizes for children.

• Wydown Park: This park has been a great success and has met the needs of the neighboring area for open green space. The Park attracts young families with children. With its public art and lush landscaping, it provides a respite for residents of all ages.

We were glad to have the opportunity to speak with these business owners along with Mayor Uchitelle, City Manager Schoedel, many City staff members and some residents. It is important that we communicate on an ongoing basis as we all strive for balance between business and neighborhood needs, and continue to make Clayton a great place to live.

New Metrolink Extension Connects Neighborhoods, the Region

The new Extension connects seven municipalities and adds eight miles to the current system that spans 38 miles from Scott Air Force Base and Shiloh, Illinois to Lambert-St. Louis International Airport. Nine new passenger stations are part of the extension, two that serve the Clayton community. "MetroLink is a boon for Clayton residents and workers. It is a benefit to citizens of the entire Metropolitan community," said Clayton Mayor Ben Uchitelle. "We hope everyone will learn more about the MetroLink routes and how to take advantage of our light rail system."

The Storm of 2006

Clayton was hit hard by the sudden and severe storm of July 19. The combination of widespread power outages and extreme heat led City officials to declare an official state of emergency.

During the storm's aftermath, Police, Fire and Planning Departments' personnel took extraordinary measures to ensure the well-being of Clayton residents. Staff from each department went door to door to check on those who were without power. They focused on occupants living in multi-family dwellings, the majority of whom had already made arrangements with friends

or relatives. Four or five individuals were taken to cooling stations that had been set up at the Central Presbyterian Church and St. Louis County Library in Clayton. Staff continued to monitor conditions of approximately a half dozen residents until appropriate accommodations had been made.

The City also worked to keep citizens informed, and implemented various means to disseminate emergency information to those affected by this disaster.

Damage to trees was extensive. Residents helped by gathering and placing tree limbs at curbs. Clayton's Public Works Department street crews worked tenhour days and weekends for over a month clearing debris. Parks Department staff was also very busy cleaning up debris, especially in Oak Knoll Park.

The process was arduous for Clayton citizens as well as City staff. Everyone worked diligently to complete the cleanup, and the City truly appreciates the patience demonstrated by Clayton residents during the ordeal.



Leaf Collection Guidelines

- Rake leaves into curb-line. NO plastic bags, limbs or brush are allowed.
- Obey the street sweeping signs on the scheduled leaf collection day.
- All streets will be collected on the scheduled day or the following workday, rain or shine.
- When a collection day falls on a holiday, leaves will be collected the day before or the next non-holiday work day.
- In case of inclement weather (heavy rain, snow or ice), the leaf collection schedule will be modified or reduced. Please call Public Works at 314.290.8540 for a revised schedule.
- Leaves from islands, parkways and common areas will be picked up as time permits. These areas may be skipped in order to maintain the residential schedule.
- Please do not rake the leaves onto islands, parkways or common areas.
- Alley pickup is not available.

Clayton Police Department Earns CALEA Reaccreditation

When the Clayton Police Department first received international accreditation in 2000 by the Commission on Accreditation for Law Enforcement Agencies (CALEA), it was only the sixth law enforcement agency in Missouri to do so. Currently, thirty law enforcement agencies from across the State are now involved in the CALEA accreditation process. In April of this year, a three-person CALEA assessment team spent four days reviewing the Police Department's policies and procedures to ensure that Clayton maintained full compliance with the 445 internationally recognized standards.

The assessors' review confirmed that the Clayton Police Department's operations and personnel continued to epitomize the best of teamwork and professionalism. As a result of their findings, the Department was invited to serve as one of CALEA's "flagship" agencies, and the City's accreditation manager represented police agencies on a discussion panel during the national conference in Lexington, KY. Following a formal committee hearing, the Clayton Police Department was officially granted reaccredited status by the Commission on July 29, 2006. This is the third award the Department has received from CALEA and reaffirms the Department's commitment to excellence and public service.

Department of Planning & Development Receives Highest ISO Rating in the State

The Insurance Services Organization (ISO) evaluates municipal building departments throughout the United State using a system called the Building Code Effectiveness Grading Schedule (BCEGS). The BCEGS assesses the community's building codes and evaluates how well the community enforces its codes.

The BCEGS program assigns each municipality a grade ranging from 1, the highest possible, down to a grade of 10. Each municipality receives two separate grades, one for one- and two-family dwelling code enforcement and one for commercial code enforcement. The grading is done after the municipality completes an extensive survey and participates in an interview with an ISO representative.

In addition to underwriting information, a community's classification is based on various aspects of the administration of codes, review of building plans and field inspections.

Clayton's Building Department has received a BCEGS Class 2 rating for one- and two-family dwellings and a Class 2 for commercial. To illustrate how high of an accomplishment this is for the City, only one other community within the State of Missouri received a Class 2 grade, and none received a higher classification. Within the entire United States, only five communities received higher classifications. The ISO evaluations are done every five years.

JSC to Hold Public Forums

The Joint Study Committee (JSC) of Clayton and Richmond Heights, the 40-member group created to study the possible merger of the two municipal governments or the consolidation of one or more essential services, has established public input as one of its priorities. To ensure that it is on the right course, the JSC will hold two public forums.

The first will be held from 7:00 to 9:00 p.m. on Monday, October 23, at The Heights in Richmond Heights. On November 15, a second forum will be held from 7:00 to 9:00 p.m. at The Center of Clayton.

The next meeting of the JSC is scheduled for 7:00 p.m. on Wednesday, October 25, at The Center of Clayton, 50 Gay Avenue. JSC meetings are open to the public.

Rodents

The number of rodent sightings reported to St. Louis County Vector Control and Clayton's Building Division have increased recently. Aging infrastructure and construction activity have been cited as reasons for an increase throughout the Country.

Homeowners should take the following precautions to discourage rodent populations:

- Keep garbage covered at all times.
- Do not leave dog/cat food in the back yard or detached garage.
- Clean animal waste daily.
- Stack wood at least 12 inches from the ground.
- Keep property clean from debris during construction activity.
- Seal any openings to the house.
- Have a private exterminating company eradicate rodents from private property.

County Vector Control provides suggestions on various methods for controlling rodent infestation. Rodent sightings should be reported to St. Louis County Vector Control at 314.727.3097 or the City of Clayton at 314.290.8452.
