Clayton's First Woman Mayor

Former Mayors William Human, Richard Stith, Hugh Scott, Frank Kenney and Ben Uchitelle were on hand at the April 24th Board of Aldermen meeting,

when Linda Goldstein was sworn in as the twentieth Mayor of Clayton. Ms. Goldstein is the first female to occupy the office of the Mayor since the City was incorporated as a municipality of St. Louis County in 1913.

As the senior member of the Board of Aldermen, Linda has served as a Ward II Alderman for eight years, and has held

leadership roles on several boards and commissions, including the St. Louis County Municipal League.

Although unopposed, Linda ran a "Building Better Bridges" campaign. Her platform included: promoting Clayton as a regional leader; strengthening

the City's relationship with its school district; and focusing on balancing the needs of Clayton residents and businesses. "Linda's experience with and knowledge of our citizens and their needs will prove to be very beneficial in the coming years," said Ward III Alderman Alex Berger.

Linda has lived in Clayton with her husband Ben for 25 years. Their children Jeff and Karen graduated from Clayton High School.

Clayton's Aquatic Supervisor Recognized for Heroism

Clayton's Aquatics Supervisor, Kyle Henke, was recognized by the American Red Cross for saving a life in December 2006. A Clayton High School student experienced an asthmatic attack during swim team practice. Staff helped the young woman from the competition pool in The Center of Clayton and called 911. When she stopped breathing, Kyle immediately began performing rescue breaths. Shortly before Clayton's Emergency Medical Service arrived, the student began breathing on her own. In January 2007, the American Red Cross awarded Kyle the Lifesaver Award.

In 2006, three lifeguards employed by The City of Clayton received the Lifesaver Award for a near-drowning and rescue at Shaw Park Aquatic Center. The City is proud of the safety record of its Aquatics Department, and is honored to have staff recognized with this prestigious award again this year.

Wires Down

Clayton's Fire and Police Departments are committed to serving the citizens of the community. However, there are circumstances that put significant strain on the departments' ability to carry out their responsibilities as first responders. For example, during last January's powerful storm, the Fire and Police Departments received more than forty calls in just a few hours from residents reporting fallen electrical power lines. In the past, a fire truck or police car remained at the site of fallen wires until the utility company arrived to make repairs. Last year's circumstances stretched the departments' manpower to the limit.

Fallen electrical power lines create hazardous situations, and the departments understand that there are conditions that warrant having a vehicle with a firefighter or police officer on site. However, when there are forty to fifty calls about downed wires, as there were last year, it is impossible to have someone stationed at each location. Therefore, the departments have developed a new procedure.

The Clayton Fire Department, in cooperation with fire departments from twelve surrounding communities, will utilize a new warning system. The preliminary phase of the original procedure is still in place – that is, after the Fire dDepartment has been notified and has investigated the situation, the utility will be contacted and asked to dispatch a repair crew. If the Department determines that it is not necessary for a vehicle to be on site, yellow Danger/Caution tape will be used to surround the site, and one or more of the new Wire Down Emergency Call signs will be posted. The new warning signs will alert the public of the nature of the emergency. The presence of the yellow tape and the Wire Down Emergency Call signs will make it apparent that the Fire Department has investigated the scene and has notified the utility. The new signs also provide the Fire Department's phone number, if additional information is needed by residents.

Community Alert Phone System

The computerized Community Alert Phone System is maintained by the Clayton Police Department's Community Services Unit. Individuals on the Community Alert Phone System call list receive phone notifications about emergencies and crimes in Clayton and their neighborhoods.

On May 1st, the Youth Activity Center, designed from the ground up for children ages 7 through 13, opened. Hundreds of children attended during grand opening week, and were treated to activities that included open play, live equipment demonstrations, carnival games, arts and crafts and refreshments provided by Maggie Moo's, Northwest Coffee and Subway. "The kids really enjoyed trying out the new interactive equipment, and we are looking forward to adding new programs and activities," said Parks & Recreation Director Patty DeForrest.

The Youth Activity Center currently features: two Sportwalls that simulate playing baseball; the GameBike combines Playstation video games with a stationary bike exercise: and two arcade dance mats. Strive's youth line strength training equipment is also available. The equipment looks like the adult fitness strength training center equipment, however, it is scaled down in size. The equipment is ergonomically sized for a smaller person, which increases its effectiveness and reduces the chance of injury.

The Youth Activity Center's open play hours are: Monday, Wednesday, Friday 3:30 p.m. - 6:30 p.m.; Tuesday, Thursday 4:30 p.m. - 7:30 p.m.; and Saturday 10 a.m. - 1 p.m.

Clayton Adds to Its World Class Public Art Collection

Clayton is a leader in the region in many respects, not the least of which is its world class public art installations. Works by world renowned artists Carl Milles, Howard Ben Tre, Fernando Botero and Ernest Trova are on view

throughout the community.

To make the City's public art collection one of its most impressive amenities and one of the most significant in the region, the Clayton Art Commission works with developers on public art to be installed in major building projects in Clayton and partners with other entities like the St. Louis Art Museum, Washington University and the Gateway Foundation. In addition, the Art Commission raises funds to commission new work for the City.

This summer the City will be adding a new work to the collection -- a sculpture by internationally recognized artist Alice Aycock to be installed in the circle in front of The Center of Clayton.

Ms. Aycock's concept for the front of The Center of Clayton pulls the viewer towards the site with a work that is dynamic and whimsical. The work will

be approximately 19' tall and 20' square, composed of aluminum, steel and thermoformed plastic. Compositional elements include a spun aluminum cone, a pinwheel suggesting motion and playfulness, and a series of aluminum mesh drapes or skirts that seem to flutter, reflecting the energy from within the building.

"Aycock sculptures are key components of public art and museum collections throughout the United States and Europe," said Art Commission Chair Joan Cohen. "We are excited and proud to add a piece of this caliber to the Clayton public art collection."

Ms. Aycock's work was selected as part of a competitive process led by the Clayton Art Commission, working with an Artist Selection Panel made up of Clayton citizens.

The Art Commission conducted a fundraising campaign to cover the \$110,000 contract. Clayton residents, businesses and art patrons responded generously. Contributions included \$35,000 from the City of Clayton and \$10,000 from the Clayton Chamber of Commerce. Other contributors include the Regional Arts Commission, Conrad Properties, Enterprise Bank, the Clayton Parks Foundation, Irwin Union Bank, Stern Brothers, Northern Trust, Husch & Eppenberger LLC, Solon Gershman, BSI Constructors, the Michelson Organization, Pomme Restaurant and over 45 individual donors.

In May, work was completed in the circle in front of The Center to prepare it for the installation of the piece. The Clayton Art Commission expects to celebrate the installation of the Aycock sculpture in July 2007, and is planning various activities as part of this extraordinary event.

Q. I was wondering when the new 32 gallon recycling containers will be delivered.

A. Beginning the second week of June, the City will distribute the new 32 gallon recycling containers to all Clayton residents. The old containers will be collected and the new ones distributed according to the regular recycling schedule. Allied Waste employees will bring the current 18 gallon recycling bin to the curb and empty it into their truck. Instead of returning it to the rear yard, the bin will be left at the curb. City staff will collect the old bins and drop off the new container. The new containers will be dropped in the front yard; City staff will not go to the rear yard for exchanges. Residents who wish to keep their existing 18 gallon bin must tape a note with "KEEP" in large letters to the side to indicate to the recycling hauler that he must leave the bin in the rear yard.

Dates for the recycling container exchange will be posted via message boards in each neighborhood.
