City Establishes a New Vision for the Future

On Feb. 12, 2008, Mayor Linda Goldstein presented Vision 2013: Building a Bright Future, a new, ambitious vision for the City of Clayton. The vision was developed by the Clayton Board of Aldermen, Mayor Goldstein and city staff in strategic planning sessions. The new vision and planning sessions represent the catalyst for a process that will facilitate community dialogue about the city's future directions.

Becoming a regional leader as a "green" city, enhancing its position as a business center and developing a public-private foundation to fund civic goals are among the priorities established. "Clayton has always been known for innovations that strive to enhance the city's diverse lifestyles within a solid financial framework, a framework that balances residential and business interests," Goldstein said. "Our objective is to continue to be a regional leader in several areas that are critical to our larger community and the country."

Under the proposed vision, the city will emphasize sustainable practices such as: a reduction of fossil-fuel dependency, assessment of utility usage, adoption of LEED certification in the city's zoning code to incentivize new developments, expansion of citywide recycling efforts, and creation of pedestrian-friendly environments. "The city could also realize long-term cost savings by being more energy efficient," Goldstein said.

The Mayor said that Vision 2013 is a first step in a public process to move the city forward as it approaches its centennial in five years. One highlight of the vision calls for the creation of the Clayton Century Foundation, a public-private partnership that will help fund projects in the community that go beyond traditional city services, services that are currently supported by sales and property taxes.

"There are many worthy projects in Clayton that will never be realized because of budgetary limitations and the difficult policy choices that come with maintaining basic services See Vision, Page 4

In April, I celebrate my first full year as Clayton's Mayor. I am so proud of our accomplishments. However, as I reflected on our achievements and challenges, I had to pause to put things in perspective. Whatever challenges we faced or achievements we fulfilled during my first year as Mayor pale in comparison to the anguish we felt for our colleagues in the City of Kirkwood and for its citizens. Following the devastating event, we realize that some have paid a far higher price than expected in the call of public service, and we extend our condolences and compassion. As a regional partner, we truly feel connected to the Kirkwood community on a personal and human level.

Perhaps it is this sense of "connection" that best reflects my first year as your Mayor. When I ran for office, my theme was "Building Better Bridges," and I believe that is what we have begun to do in this first year. My vision is to make new connections in the region and among businesses, foster fledgling connections throughout the

community, and strengthen those traditional connections that have made Clayton so desirable for so many years. I have met with our neighboring suburban mayors, St. Louis County Executive Charlie Dooley and St. Louis Mayor Francis Slay to expand the lines of communication that are critical to issues ranging from the Highway 64/40 closure to competition for corporations that are interested in locating or relocating in the region. I take the City's involvement in the St. Louis County Municipal League very seriously as we exchange perspectives and seek solutions.

We have initiated that same spirit of outreach with residential and neighborhood associations and welcome all opportunities to create positive dialogue with our citizens. The City is committed to a transparent governmental process regarding all matters, including redevelopment, by conducting public outreach meetings and multiple opportunities for public engagement.

Clayton is a vibrant community in which to live and do business. To preserve its economic viability in an increasingly competitive world is essential. We must maintain our connections with the Clayton Chamber, the RCGA and the County to recruit and retain businesses.

Clayton symbolizes stability. That stability is sustained by a solid financial base for City services, a City Hall staff second to none and civically-minded citizens who are always ready to put their shoulder to the wheel to make Clayton an even better place. Additionally, my colleagues bring an unprecedented level of commitment, concern and conscientiousness to their jobs as Aldermen. Together we have created Vision 2013: Building a Bright Future, a strategic document that sets three main goals. In addition to strengthening our partnerships, we are committed to promoting Clayton as a regional leader and balancing residential and business needs.

Our school district is one of the City's greatest assets. In strengthening our partnerships, we are dedicated to maintaining the positive relationship we have with its leadership through meeting regularly, participating in their "sustainability in education" program and involving them in City decisions that impact the district. The connection between the City and School District is a positive and productive one.

As a regional leader, Clayton is at the forefront of the environmental initiative. We are working with a diverse group of stakeholders and experts to create a regional program for reducing the St. Louis area's ecological footprint. I have been named the honorary chair of the Government Sector for the Greening of the Heartland Conference in June, and presented at the "Climate Action Summit: Local Action against Global Warming" conference in March. Public action on environmental responsibility is something I believe we owe our children and future generations of Clayton residents.

So what is ahead of us in the coming year? First and foremost is recruiting a topnotch City Manager who will bring the best administrative skills to our City. The Board of Aldermen and I hope this individual will be in place soon, but we must perform our due diligence to ensure we have the right person to represent Clayton. We will encourage community input and help in fleshing out our Vision 2013 centennial plan, and remain committed to an improved tax balance that will ease the burden on residences without affecting our quality city services or the prestige of our business community.

These are tall orders, but we can do it together. Clayton will continue to shine as one of the premier communities in the St. Louis region and the preferred place to be. But, at the same time, we must remain connected within our community and with our partners throughout the area.

For things they are a changing

- Change is saying goodbye to City Manager Mike Schoedel. We thank him for his leadership and stewardship of our city. His accomplishments are many and he leaves behind a great staff and our community is better off than when he arrived. We want to recognize and thank him for his contribution to elevating and maintaining our city as the leadership city that it is. Thanks Mike!
- Change is the number of development projects that are in the queue. How development is viewed today has changed. Public/private partnerships have become the norm. Due diligence surrounding the

assessment and evaluation of development proposals is more complex now than before.

- Change is the cost of doing the city business. The ability of suppliers to maintain their price points caused by the increase in fuel prices poses a challenge to our plans for capital projects and how the city manages both its general fund, and operating budget.
- Change is initiating priorities and a vision plan for the future. We are early investors in that initiative and proactively support expanding the planning initiative beyond the visioning statement.
- Change is meeting the challenge of communicating with and engaging our citizens. Establishing multiple communication and contact channels to network with citizens is clearly a top priority.
- Change is using past experience to develop the new. The city's continued evaluation and improvement of its systems and procedures to come to the aid of our citizens in the event of a natural disaster is another important change.
- Change is improving the processes to create new and timely solutions in response to the everyday service needs of our citizens and residential neighborhoods.
- Change is making choices. The list of potential capital projects is expanding. Determining what are the top priorities and how to fund those expenditures is a mandate.

Status quo will not serve our community well. There will be a new city manager. Some stakeholders in our community may leave and new ones will arrive. During 2008, we will be both buoyed and challenged by change. What enables Clayton to differentiate itself from the other municipalities facing change is the capability and effort made by our outstanding city staff and the extraordinary commitment of our citizens to participate in our city and community.

While we are changing, those two elements need never change!

City Manager Search Process

In December 2007, the City of Clayton initiated a national recruitment process to find a replacement for City Manager Mike Schoedel, who had announced his resignation in order to take a position in the private sector. Mr. Schoedel left city government in mid-February for employment with Apex Oil.

The deadline for applicants was January 31, 2008. Approximately fifty applications were received from across the country. From this pool, a select group was being interviewed in a two-stage process over the past several weeks.

In conjunction with the recruitment process, the Mayor and Board of Aldermen worked with Donna Zajonc, a political leadership consultant, to further define desired characteristics of the new City Manager and roles and responsibilities under the Council/Manager form of government. This helped focus the selection process to ensure the best candidate would be chosen to meet the needs of the Clayton community.

In the interim, Lenore Toser-Aldaz has been serving as Acting City Manager. Ms. Toser-Aldaz is the Deputy City Manager and has been with the City of Clayton for the past eight years. Throughout her tenure, she has been directly involved in all aspects of the City's activities, including the budget process and economic development initiatives. In addition, as the Deputy, she has had oversight responsibility for the areas of human resources, Parks and Recreation, Public Works, and Management Information Services. If all goes as planned, a new City Manager will be on board sometime this spring or early summer.

The meetings provide business owners

opportunity to discuss a variety of issues facing the retail community. At the April meeting, cooperative advertising campaigns will be considered. "Before we decide on anything, we want to get everyone's input at the April meeting," said Jay Cicerelli. Besides meetings, input will be obtained from a survey designed to help determine the best ways for the Association to serve the greater Clayton retail community. The survey was mailed to all retail business owners in Clayton, who are asked to complete and return the survey.

The CMA also encourages businesses to participate in the Mid-Metro 4 program. Mid-Metro 4 is a coalition formed by the cities of Brentwood, Clayton, Maplewood and Richmond Heights to promote businesses in

the four communities during the reconstruction of I-64. Mid-Metro 4 has created a website www. midmetro4.com, where businesses can register promotions. and customers can find details about member businesses and their

with tax dollars," Goldstein said. The Foundation will develop a coordinated fundraising plan consistent with the city's mission and priorities. Through the work of the Foundation, the city will reach out to residential and corporate private partners for support in enriching quality of life initiatives. Additionally, the Foundation will promote the city's history and plan for the celebration of Clayton's 100th anniversary in 2013.


Among other notable elements of the vision are:

- Maintain world-class core services, such as public safety and infrastructure, with measurable outcomes to evaluate city implementation.
- Retain and attract businesses and corporate headquarters, encourage greater density and mixeduse development in the Central Business District including more residential properties, and design specific strategies to increase the vibrancy of downtown Clayton.
- Strengthen partnerships with the Clayton School District, the Clayton Chamber of Commerce, area universities and other community groups.
- Achieve a better balance in tax revenue levels to shift from a disproportionate share paid by residents to revenue derived from business and redevelopment.
- Coordinate with neighboring cities to reduce duplication of efforts, share marketing initiatives and look for savings.
- Expand avenues to communicate with residents and businesses.

Goldstein said Vision 2013 is designed to provide guidelines for engaging the public in discussions and planning for a vital future. The mayor added that the city must also address immediate issues, including recruitment of a new city manager and consideration of proposed new developments.

On Feb. 12, 2008, the Clayton Fire Department announced the appointment of Paul V. Mercurio III as the new Assistant Chief/Fire Marshal. Assistant Chief Mercurio will replace John Laventure, who retired last month with over twenty-five years of service to Clayton.

Assistant Chief Mercurio was chosen following an extensive selection process. He comes to the Clayton Fire Department from West County EMS & Fire Protection District in St. Louis County with over twenty-four years of fire service including the last nine years as Fire Marshal. Assistant Chief Mercurio's qualifications include a B.S. Degree in Fire Service Management from Maryville University, certification by the State of Missouri as a Fire

Investigator, Fire Inspector, Fire Service Instructor, Emergency Vehicle Operator II, Fire Officer 1 & 2 and licensed paramedic. Additionally, he is a member of numerous fire service related associations.

"Assistant Chief Mercurio has an extensive background and experience as both a Fire Marshal and Fire Officer and will be a great asset to the department and community," said Fire Chief Mark Thorp. "We are glad he is joining our team."

Alternate Modes of Travel

The Visioning for the Future document recently approved by the Board of Aldermen includes maintaining the City's status as a leader in environmental initiatives as one of its main goals. A strategy under this goal is to develop specific plans to encourage bicycling as an alternative mode of transportation in Clayton.

To support this strategy, plans are for Wydown Boulevard to be restriped as part of a microsurfacing project. The restriping will add bike lanes along Wydown, will address vehicular traffic and existing parking. Identification of the proposed bike lanes will be reinforced with new signage.
