### Fine Tuning the City's Vision of the Future

In the February and April issues of CityViews, we studied Clayton's impressive public safety services and economic development efforts. The City's exceptional planning and sustainability initiatives are recapped in this issue.

Clayton is committed to creating and maintaining a beautiful, clean and healthy community and to being a leader in environmental initiatives. Using resources responsibly, sustainability is incorporated into daily operations without increasing expenses. Working with development community, the City encourages the use of best practices such as LEED (Leadership in Energy and Environmental Design) certification and runoff water mitigation with new construction.

Clayton's impressive history as a leader in the environmental

movement started with its residential recycling program approximately 15 years ago. Clayton was the first of two cities in Missouri to implement a LEED certification ordinance and was the second of St. Louis County's 91 municipalities to adopt a citywide ban on smoking in public places.

Among its more recent accomplishments, the City became the first Green Power Community in Missouri for its commitment to renewable energy. It achieved Milestone One for Climate Mitigation in ICLEI's Local Governments for Sustainability program. The City's Planning and Development Services Department includes a Resources for Sustainable Development with all site plan and architectural review applications. The City's fleet is 89% green with 107 of its 120 vehicles either bio-diesel or hybrids. All cleaning and paper products used in City facilities are green products, which has resulted in a 40% reduction in cost.

In 2010, the City was recognized for its environmental efforts. Clayton was awarded two Energize Missouri Communities grants for the Public Building Energy Efficiency Retrofit of the new Police Station building achieve renovation to Silver Certification and a Special Community Initiative to install a solar photovoltaic. Clayton was named one of the St. Louis Business Journal's Heroes of the Planet — Sustainable Community Finalist for its leadership advancing and promoting environmental sustainability in the St. Louis region.

The Planning Department has also been recognized by the American Planning Association who named Wydown Boulevard as one of the 10 Great Streets of 2010 for its exemplary quality and character.

The department's ISO (international building standards) rating of 2 for residential and 2 for commercial (10 being the lowest) is the highest rating of all building departments in Missouri.

This series of reports on City services will continue. The City's recreational and cultural activities will be highlighted in the August issue of CityViews.

On March 23, Clayton officially became the first Green Power Community in Missouri -- we could not have done it without you!

We achieved the 2% green power requirement necessary to become the first Green Power Community in Missouri. Only 37 cities nationwide qualify for the elite list of partners of the Environmental Protection Agency (EPA) in purchasing green power.

In a joint effort with Ameren Missouri Pure Power and Clayton-based Microgrid Energy, the City launched the challenge in July of 2010 with the goal of achieving GPC status by Earth Day 2011. A large commitment by Duke Realty Corporation, on behalf of their tenants in the 101 South Hanley building, helped Clayton achieve its 2% goal a month early. Duke Realty joined the City of Clayton, the Clayton School District, Concordia Seminary, 28 additional businesses and over 200 Clayton residents in achieving Clayton challenge goal.

We are thrilled with the response from the Clayton community in achieving this first in Missouri distinction. Clayton has been at the forefront of many environmental initiatives, but this one is truly a community achievement. I am impressed not only with the level and breadth of support by our business and residential citizens but more importantly with their true commitment to green power. I would like to offer my congratulations and thanks to each and every Clayton business and resident who helped the City achieve the Green Power Community designation.

In recognition of this achievement, a community celebration was held on Wednesday, April 20 in Shaw Park. All Clayton business and residential citizens were invited to attend. The Clayton High School Jazz Ensemble performed and GPC Challenge supporters Companion Bakery, Kaldi's Coffee, Remy's Kitchen and Wine Bar, The Wine Merchant and Purus Organic Vodka provided celebratory food and drink for all. Congressman Russ Carnahan and other dignitaries were on hand to recognize Clayton's amazing achievement.

What a proud moment for me and the entire Clayton community.

#### CDBG PUBLIC HEARING

The City of Clayton will hold a public hearing to discuss the allocation of \$22,500 in Community Development Block Grant (CDBG) funds, which will become available after January 1, 2012. The public hearing will be held at 12:30 p.m. on Wednesday, June 22, 2011, in Conference Room A on the first floor of Clayton City Hall at 10 N. Bemiston Avenue in Clayton, Missouri.

To further its commitment to fair and equitable treatment of all citizens, the City of Clayton has enacted and/or enforces the following: a Fair Housing Ordinance prohibiting unlawful discrimination against any person because of race, sex, color, religion, disability, familial status or national origin; a Policy of Nondiscrimination on the Basis of Disability in the admission or access to or employment in its federally assisted programs or activities; a Policy of Equal Opportunity to Participate in Municipal Programs and Services regardless of race, color, religion, sex, age, disability, familial status, national origin or political affiliation; a requirement for bidding on CDBG activities that promotes employment opportunities created by HUD funding and that these opportunities be afforded lowincome community residents and businesses.

# Forsyth and N. Meramec Resurfaced This Summer

As reported in the previous edition of CityViews, Forsyth Boulevard (throughout Clayton) and N. Meramec Avenue (Maryland Avenue to northern City limit) will be resurfaced this summer. The first phase of the project will consist of the replacement of curb ramps that are not currently in compliance with the Americans with Disabilities Act (ADA), and the installation of new crosswalks at various intersections. These crosswalks will consist of precast concrete "bricks" on a concrete base, and will be more permanent and maintenancefree than the existing textured crosswalks. There will be lane closures during off-peak hours to facilitate the replacement of the curb ramps and crosswalks. There will also be times on weekends when full crosswalks will be under construction.

closing that leg of the intersection to traffic. However, work will be phased to maintain traffic flow around the work area (vehicular and pedestrian).

Upon completion of the curb ramp and crosswalk work, approximately two inches of asphalt will be removed and replaced with a new asphalt surface. With the exception of the residential area of N. Forsyth Boulevard, most of the milling and paving work will occur on weekends due to high weekday traffic volumes. There will be lane closures and complete road closures at times.

APWA annually recognizes 10 of the most outstanding Public Works professionals from across the United States and Canada for their career-long dedication and service, professionalism, and expertise in Public Works infrastructure. As one of the most coveted and prestigious awards presented by the association, the Top Ten Public Works Leaders award is given to honor the Public Works professional's career in which he or she demonstrated excellence in Public Works services and infrastructure in his community through advancement of Public Works services and technology.

Over his 37 years of service with the City

of Clayton Public Works Department, Gary rose through the ranks from clerk to Public Works Superintendent. For the last 22 years, he has been directly responsible for the supervision of personnel who maintain streets, forestry and grounds, street lighting, parking and signage/striping operations within the Public Works Department. He personally plans most of the logistics for the large-scale community events held in Clayton.

Gary was recognized for his achievements at the May 10 Board of Aldermen meeting and presented the award plaque by APWA Board Director Region VI, Larry Stevens, P.E., at a reception at the Crowne Plaza on May 16. Each of the Top Ten Publics Works Leaders will be honored during the awards ceremony at the APWA 2011 International Public Works Congress & Exposition in Denver, Colorado in September.

### Citizen Satisfaction Survey Results

the City continues to live up to community expectations

In an ongoing effort to improve performance, the City solicits opinions from Clayton residents on an annual basis. Each year, the citizen satisfaction survey is conducted to gauge how the community rates the quality of City services. ETC Institute, a national leader in the design and administration of market research for local governments, helped administer the 2011 Clayton citizen satisfaction survey.

Results of the 2011 survey, which was sent to 1,800 randomly selected households in March, were presented to the Board of Aldermen on May 10. Major findings show that 96% of the residents surveyed feel that the quality of life in Clayton is excellent/good; 94% are very satisfied/satisfied with the quality of public safety services and 92% with the overall quality of City services.

"The expectations of City government are very high in Clayton," ETC Institute's Karen Falk told the Board during her presentation in May. "Your residents should know that the survey provides measurable proof that your City is meeting those expectations by comparing your ratings to similar communities across the country."

Benchmarks that compare Clayton to other municipalities regionally and nationally show 91% of the survey respondents in Clayton feel safe in their neighborhoods compared to 75% in other cities in the region and 68% nationally. Clayton is ranked significantly higher, in some cases more than 35% higher, in satisfaction with the City's efforts in preventing crime and fires, in providing customer service, in keeping the community informed, in maintaining streets and managing traffic flow.

The City plans to conduct citizen surveys annually to maintain the mutual recognition between City staff and the community it serves. The final results of all citizen surveys are available at claytomo.gov/citizensurvey
