The final elements of the Strategic Planning process were presented to the Board of Aldermen on November 13, 2012. Members of the Strategic Plan Steering Committee Steve Lichtenfeld, John Lee and Dr. Sharmon Wilkinson introduced the new Vision Statement and four Key Performance Areas (KPA).

These elements are the result of a process that began in March 2012 and dubbed *C the Future*. The Novak Consulting Group, who facilitated the Strategic Planning process, conducted focus groups and meetings with the Steering Committee.

The Steering Committee invited members of the community to participate. Fifty stakeholders committed to the two-part Future Search Conference process, a Vision Conference and an Action Conference. At the Vision Conference in early June, social, political, economic, environmental and technological trends important to Clayton's future were studied. This visioning process resulted in a draft vision statement and twelve key performance areas. Via an interactive citizen engagement website called ClaytonConnects, the entire community was able to engage in a dynamic online conversation and share their perspectives, ideas, visions and aspirations for Clayton's future.

Open houses in August offered additional opportunities for stakeholders to provide input and comments. The feedback obtained

from ClaytonConnects and the open houses became part of the dialogue for the conference participants as they structured long and short term action plans.

"We are grateful for the amazing response from the community," said Mayor Linda Goldstein. "We hope everyone will view the final Strategic Plan document to see how their input helped shape Clayton's future."

The fifty stakeholders reconvened at the Action Conference in September. They reviewed and refined the draft Vision Statement and reduced the number of Key Performance Areas from twelve to four.

In late October, the Steering Committee reviewed the final four KPAs and discussed the process of selecting individuals to serve on Action Committees. The Action Committees are responsible for executing each of the KPAs which is the culmination of the process.

"C the Future provided all Clayton stakeholders the unique opportunity to engage in the creation of their desired future," said The Novak Consulting Group President Julia Novak. "The result of this inclusive process is truly a community vision for Clayton, and it is something that should be celebrated as the city enters into its next 100 years."

### City Passes Budget and Three Year Plan to Reduce Budget Deficit

The city started the recession with strong reserves, but continues to face challenges due to the effects of the protracted recession. Since 2010, expenditures have exceeded revenues. During various forums held to review and discuss the new budget. policy makers and community stakeholders encouraged using the city's significant reserves in the short-term so as not to reduce service levels.

With a newly approved three year plan for deficit reduction in place, the city will strive to maintain the majority of services at or near the current levels and eliminate the General Fund structural deficit through a combination of increased efficiencies, strategic expense reduction in some service areas, and increased revenue. This approach will help preserve the fund balance for future opportunities or unforeseen financial challenges, maintain the city's quality of life and the city's position for economic growth.

#### **Personnel**

Results of the annual citizen satisfaction survey indicate that citizens are satisfied with service delivery and believe they receive good value for their tax dollars.

Nevertheless, city management conducts careful reviews of personnel expenditures. Before hiring to file a vacant position, management evaluates whether elimination. consolidation or reclassification of the position is possible. Over the past five years, the city has reduced five full-time positions, many at the administrative support and management level. Reduction in these

areas limits the impact on front-line service delivery to citizens.

Service efficiencies and the recently implemented Deferred Retirement Option Plan will accelerate cost savings when a number of positions are consolidated or eliminated during the next year through retirements. Further analysis will determine if reduction in staffing levels will be implemented later in the deficit reduction plan.

#### **Pension and Health Insurance**

One of the largest increases in expenses has been contributions the city makes to respond to the loss in value of the employee pension funds. In an effort to keep the funds healthy and to prepare for retirement commitments, contributions by non-uniformed employees were reinstated over the last two years and employees are now making 3% contributions. Uniformed employees have contributed 5% for several years.

Health insurance has also increased by almost \$500,000 over the past five years. To aid in controlling insurance costs, the city helped form a self-insurance pool with several other municipalities. Additionally, benefit levels and co-pays are monitored and adjusted to limit premium increases which are ultimately shared with employees.

### **Infrastructure and Capital Improvements**


Besides helping to reduce the impact of rising personnel costs, city employees work to generate funds for capital improvement

projects. But even with staff's impressive record for grant funding awards and generous corporate donations, funds are not available for several major residential street resurfacing projects in some of the largest neighborhoods. Project funds are planned to be generated by a 20 year general obligation bond program supported by a property tax levy. These funds will be used to finance five significant residential street resurfacing projects that total \$15 million, making it possible to overhaul 56% of the citymaintained streets between 2014 and 2016.

#### **Three Year Deficit Elimination Plan**

Residents responding to the 2012 citizen satisfaction survey indicate that they would prefer raising taxes to reducing services. Property, sales and utility taxes will be unchanged in FY2013 per the three year deficit elimination plan. However in FY2014, the plan proposes a ½ cent increase in sales tax. To fund the needed residential street improvements, voters will be asked to approve a property tax supported bond issue which will increase residential and commercial property tax rates by approximately 12 cents per \$100 of assessed value. Currently, the city's portion of the tax bills for residential and commercial property owners is approximately 10%.

Reinforced by input from the community, increased efficiencies and taxes, and through careful monitoring, the city works to execute the three year plan to eliminate the budget deficit. To view the approved FY2013 **Operating and Capital Improvements Budget** go to www.claytonmo.gov/budget.



### Elleard Heffern Fine Jewelers Celebrates Centennial

On March 19, 2013, Elleard Heffern Fine Jewelers will commemorate 100 years in business. Christopher "Kit" Heffern's grandfather Samuel Heffern and Great Uncle George Neuhoff, Jr. founded the Heffern-Neuhoff Jewelers in March 1913, located in downtown St. Louis. ### **Accreditation for Parks & Recreation Department**

Over the last two years, the city's Parks & Recreation Department has been working through the process of becoming an accredited agency with the Commission for Accreditation of Parks and Recreation Agencies (CAPRA). The process is a significant undertaking. To become accredited, the department had to demonstrate its commitment to the field by complying with a body of standards deemed essential to the quality of services delivered and professionalism of its operational



system, as well as best management practices in daily operations. Clayton's Parks & Recreation Department met the required standards and was honored at the National Recreation and Parks Association Congress held in Anaheim, California in October.

Clayton becomes the fourth agency in Missouri to receive this distinction, the second in the St. Louis metropolitan area, and one of 109 accredited agencies across the United States.

### Friends of the Parks

Clayton's Parks and Recreation Department is participating in the statewide Friends of the Parks initiative, which is designed to educate citizens about the economic, environmental, health and educational benefits of parks and recreation. ### Public Works Update

Two federally-funded (80%) projects are scheduled for construction in 2013. The first is the Traffic Signal Improvement Project, which will start during the winter and includes new vehicle detection and signal timing to improve traffic flow and minimize congestion. The 2012 Citizen Survey results indicated that the flow of traffic and congestion management was one of the top three services that residents thought should receive the most increase in emphasis. Starting in spring 2013, the other federally funded project, the Pedestrian Enhancement Project, will expand the Downtown Streetscape along Bonhomme Avenue, S. Central Avenue, and S. Meramec Avenue. It will also improve pedestrian accessibility at the northeast corner of Shaw Park Drive and Brentwood Boulevard.

Smaller, locally-funded projects include the painting of traffic signal posts, replacement of sidewalk slabs, cracksealing roads and alleys and plumbing repairs to the 8011 Bonhomme Parking Garage. The Engineering Division is also busy designing multiple projects to be constructed in 2014 and beyond. Grants have been secured, and design is underway for the resurfacing of Wydown Boulevard and the expansion of Downtown Streetscape along Brentwood Boulevard and Carondelet Avenue. Both of these projects are scheduled for 2014 construction. In addition, several large residential resurfacing projects are scheduled for 2014 and 2015.
