2013 in Review

Amid all the centennial excitement, the city still managed to earn awards and recognitions for its outstanding performance. In 2013, the city:

- was recognized for its Complete Streets Policy and as One of the Top 10 Best in the Nation by the National Complete Streets Coalition based in Washington, DC
- · was recognized for its environmental leadership when the United States Green Building Council - Missouri Gateway selected the solar array on the new police station as



one of the two projects presented at the 10th Annual LEED Showcase

- was named a Bronze Level Bicycle Friendly Community by the League of American Bicyclists for promoting the creation of a network that accommodates all bicyclists, pedestrian, transit users and motorists
- accepted the 2013 AccessibleSTL Shine the Light Award in recognition of the city's efforts to promote a fully accessible community for people with disabilities
- was named Tree City USA for the twenty-first consecutive year
- received the Exemplary Intergovernmental Collaboration award from East West Gateway recognizing the city's role in the Fire Mutual Aid System and the development and implementation of emergency operational guidelines for the fifteen cooperating fire departments
- was recognized by the Department of Defense Employer Support of the Guard &

Reserve, which promotes cooperation and understanding between Reserve Component Service members and their civilian employers

- dedicated its new Police and Municipal Court Building – putting public safety first while preserving historic aspects of the Heritage Building in the process
- opened the new dog park in Anderson Park
- permanently installed a 19-foot, bronze and stainless steel sculpture by James Surls in Shaw Park's Century Garden.

The Clayton Century Foundation also received an award in 2013. The St. Louis County Municipal League presented the foundation the "Muni" Award recognizing the impressive initiatives demonstrated during the city's 2013 centennial year celebration.

Since its incorporation in 1913, Clayton has experienced a steady and prosperous growth. With such a formidable history, the city looks forward with confidence to retaining its exceptional quality of life and premier status in the region.



Both systems are used in case of emergencies such as long time power outage or to inform residents of cooling or heating stations. News from Ward III



Last year, a group of citizens, elected officials and staff worked to develop a long range strategic plan for the City. One of the priorities identified in the plan is "economic development and vibrant downtown".

A few months ago a group of community volunteers, business owners and the Aldermen from Ward 3 began developing the strategies and specific actions to initiate change. One of the initiatives the group is working on is the development of a Downtown Clayton Mobile Application (an "app").

The app will provide valuable exposure to Clayton's dining, shopping and entertainment establishments. It will facilitate communication with our businesses, encourage local shopping, and boost economic development. Every merchant will have a complimentary listing in the app which will include contact information, hours of operation, store description, and social media links. Besides much needed exposure, the app will provide a free marketing tool for Clayton merchants. Because business locations will be indicated on the directory map and business names will appear on the list view, users can find a business quickly and easily. City of Clayton maps, event calendars, and social media integration will also be available. The City will also be able to use the app to push notifications about important news items.

Mobile communication and interface, using smart phones, tablets and computers, link individuals with information that will help to meet their needs and support their decisions. This increased connection translates into increased visibility and business.

The City of Clayton is committed to supporting our business community. The feedback and reaction of our City's restaurant and retail community has been very positive.

2014 Municipal Election

On Tuesday, April 8, 2014, the City of Clayton will hold a municipal election for the office of Alderman–Ward 1, Alderman–Ward 2 and Alderman–Ward 3, each for a three-year term.

Persons interested in running for the office of Alderman are required to file a Declaration of Candidacy form which can be obtained from the City Clerk's office at Clayton City Hall, 10 N. Bemiston Avenue. The filing period will begin at 8 a.m. on Tuesday, December 17, 2013 and end on Tuesday, January 21, 2014 at 5 p.m.

Candidates must be at least 25 years of age, a registered voter and have lived in Clayton for at least two years prior to the election date.

The City Asks Residents, "How Are We Doing?"

The city conducts citizen satisfaction surveys to establish an accurate read on the needs of the community and to determine how those needs are changing. The survey results also help city staff establish priorities and match budget allocations to resources.

To ensure that services continue to live up to community expectations, the city is again conducting a survey; the 2014 survey process began in November. With the assistance of the ETC Institute of Olathe, Kansas, surveys were mailed to 1,800 randomly selected Clayton households. Residents receiving the surveys were asked to evaluate services provided by the city. Of the 1,800 surveys mailed, a minimum of 400 responses must be returned for the survey to be statistically valid.

"Residents of Clayton clearly understand that the City values their input, because gathering the number of responses for statistical validity has never been a problem," said ETC's Karen Falk.

In the past, the city has received outstanding marks from the citizens' responses to the survey questions. This not only signifies the community's satisfaction with municipal services, Clayton ranks far above cities locally and nationally that submit their survey results to the International City/County Management Association (ICMA) Center for Performance Measurement for comparison with their peers.

Responses are being collected and data compiled. When the process is completed, the results will be analyzed and a final report presented to the Board of Aldermen early this spring.

Bicycle Friendly Community

Clayton was named a Bronze Level Bicycle Friendly Community (BFC) by The League of American Bicyclists. In October, representatives from Trailnet presented the award to Mayor Sanger and Board of Aldermen. The award recognizes the city for embracing the environmental, financial and quality of life benefits of bicycling. It recognizes Clayton's commitment to improving conditions for bicycling through investment in promotion, education programs, infrastructure and pro-bicycling policies.

Through its Complete Streets policy, named one of the top 10 new Complete Streets policies in the United States, Clayton promotes the creation of a network that accommodates all users including bicyclists, pedestrians, transit users and motorists. Clayton is a leader in the field, and the Missouri Bicycle and Pedestrian Federation urges communities across Missouri to follow Clayton's example.

Shine the Light Award

In November, Clayton's Mayor Harold Sanger accepted a 2013 Accessible STL Shine the Light Award from Paraquad on behalf of the city and its efforts to promote a fully accessible community for people with disabilities.

"With over 45,000 people working, visiting and shopping in Clayton every day, the city is dedicated to assuring that everyone has access without restrictions," said Mayor Sanger.

Clayton's sidewalks and intersections are some of the most accessible in the United State according to Paraquad. In addition to textured curb ramps and crosswalks, the city installed audible crossing signals for people with visual impairments.

The city also requires first responders to undergo regular training to provide

dignified service to people with disabilities, and the city's ADA coordinator ensures that residents with disabilities have full access to recreational programs.

Paraquad honored the City of Clayton with a 2013 AccessibleSTL Shine the Light Award for serving as a model city for accessibility.

Local Government Achievement Award

The Central Core Fire Chiefs Working Group received an award from East West Gateway for Exemplary Intergovernmental Collaboration in November. Spearheaded by Clayton's Fire Chief Mark Thorp, the group was honored for cooperative efforts between local government jurisdictions or agencies for developing and implementing standardized emergency operational guidelines (SOGs) for the fifteen cooperating fire departments.

Fire departments routinely rely on each other for assistance at fires and other emergencies. Prior to this effort, however, each department had different operating practices.

With this universal set of SOGs, the departments now perform vital actions as if they are one department. The mutual aid system results in positive changes that are improving service to the communities and safety for firefighters.

Cindy Lerick - 2015 IFEA World Board Chair

Last fall, the Executive Director of the Saint Louis Art Fair Cindy Lerick was appointed 2014 Chair Elect, 2015 Chair of the IFEA World Board of Directors. The IFEA (International Festivals and Events Association) World Board of Directors is an elected, non-compensated body of industry professionals responsible for overseeing the successful operations of the IFEA. In addition to approving policy and direction, Board members serve as an active and involved industry leadership advisory source to the President & CEO.

Other Chairmen of the IFEA Board included directors of the Rotterdam Festivals, SunFest of Palm Beach County, Pasadena Tournament of Roses, Fiesta Bowl, Portland Rose Festival, Kentucky Derby Festival and Fiesta San Antonio.

"This is an outstanding accomplishment and speaks to Cindy's leadership in the industry," said Mayor Harold Sanger. "We are proud of her and the manner in which she represents Cultural Festivals and the Saint Louis Art Fair on a national and international level. Congratulations, Cindy, well deserved!"

Clayton's Remarkable Crime Statistics

The crime statistic website, CityRating.com, targets individuals who are researching places to live. The site uses the National and Local Crime rates reported in 2010. After verifying that the correct data is used for Clayton statistics, Police Chief Tom Byrne found that Violent Crime in Clayton is 79.84% below national average and property crime is 37.88% below average. Missouri statistics show that Clayton's violent crime rate is 82.12% below the state average and property crime is 45.39% below.

Clayton's Police Department is dedicated to keeping Clayton safe. With crime statistics like these, Clayton business and residential citizens can rest assured that they are in one of the safest places to live and work.

Redistricting

The process of drawing electoral district boundaries by arranging a jurisdiction's census blocks into equally-populated, compact and contiguous districts

Clayton's City Charter requires ward boundaries to be reviewed following the release of each decennial census. The process is assigned to a Boundary Commission consisting of one registered voter from each of the city's three wards. The commission is responsible for drawing new ward boundaries based on the 2010 census data. In August 2013, the Board of Aldermen appointed Jeanne Most from Ward I, Chuck Farris from Ward II and Sandy MacLean from Ward III to serve on the commission.

The commission met several times in October to discuss the redistricting process and possible changes in ward boundaries. Using the required redistricting criteria, it was determined that the current wards deviate too much in terms of population, and upon review of several different redistricting

scenarios, the commission recommended changing the boundaries between Ward 2 (the least populated) and Ward 3 (the most populated) in order to have more equally populated wards.

The proposed recommendation was presented to the Board of Aldermen at a public hearing in December; the Aldermen may adopt, reject, or modify the recommendations of the commission. The Board's decision, whether or not to adopt the recommended redistricting scenario, will appear in the April issue of CityViews. If the option is adopted, the new ward boundaries will go into effect with the next local election in 2014.

The City Needs Your Input

The City of Clayton needs your feedback on a series of proposals to keep the city strong. These proposals include implementing a long-range plan for the city roadways, continuing economic development efforts to increase downtown Clayton's vibrancy and maintaining quality emergency services.

The proposals are based on the goals and vision set forth in the community-created C-The Future Strategic Plan and Clayton's Downtown Plan. They are also part of the effort to eliminate the structural deficit in the city's operating budget.

Commitment to Safety

Demonstrating its ongoing commitment to the safety of the Clayton community, the Clayton Fire Department participated in two disaster preparedness programs during fall 2013.

The department made special arrangements with the University of Missouri Fire Rescue Training Institute to



conduct a Trench Rescue Technician Certification program here in Clayton. Classes were held in the Gay Field Maintenance Facility. The Clayton School District allowed the department to use an area by the maintenance facility for the trench. Clayton's Public Works Department provided the backhoe to dig the trench. The training is part of the department's on-going specialty training program based on its Strategic Plan and Threat & Risk Assessment and is one of eight certifications required for its Hazards & Vulnerability Assessment.

Members of the department also participated in the 2013 Operational Readiness Exercise in Columbia, Missouri. The disaster exercise simulated an earthquake with collapsed buildings, hundreds of injuries and over sixty fatalities.

"Participation in these exercises has improved the ability of our department to respond to disasters," said Fire Chief Mark Thorp. "They help us maintain the high level of service we provide to the residents of Clayton."

Wydown Boulevard Resurfacing Project

As part of the City's pavement maintenance program, Wydown Boulevard will be resurfaced this summer. Planning for this project began in February 2011, when the City applied for and received a \$3M Federal grant through the East-West Gateway Council of Governments. It is anticipated that project will be advertised for bids in January and work will begin in the spring, as soon as weather permits. The first phase of the project will consist of the replacement of defective curbs and gutters, replacement of non-ADA-compliant curb ramps, and installation of new crosswalks. These crosswalks will consist of precast concrete "bricks" on a concrete base, and will be more permanent and maintenance-free than the existing textured crosswalks. The crosswalks located at Audubon and at Dartford were built using this new technique, and will remain in place. Upon completion of the first phase, approximately two inches of asphalt will be removed from the roadway. The concrete base will be replaced on an as-needed basis prior to installing two inches of new asphalt. There will be lane shifts at times to facilitate this work, but full road closures are not anticipated. For more information on this and other projects, please visit www.claytonmo.gov/projects.
