



Proposed Mixed Use Development

On November 16, GBT Realty, of Nashville, Tennessee, presented a conceptual design for a mixed use development to the Planning Commission/Architectural Review Board. The proposed project, located at the site of the former Schnucks store at Clayton and Hanley Road, would include a grocery store, retail shops, a restaurant, office space, a 44-unit residential facility, a 12-story residential tower with 247-units, a parking garage, surface parking, and open space.

After conceptual review by the Planning Commission/Architectural Review Board, the developer may submit plans to rezone the property and City staff will go through a detailed review of the proposal. The proposed project would be developed as a Planned Unit Development (PUD) and would require public hearings before the Planning Commission and Board of Aldermen.

Clayton Fulfilling Downtown Master Plan

In November 2010, the Board of Aldermen adopted updates to the Downtown Master Plan. The plan provides the City with a vision for future development opportunities and civic improvement. The plan adoption followed a comprehensive year-long process of gathering information, analyzing data, collecting considerable public input, identifying weaknesses, and establishing priorities. The goal of the plan is to grow downtown Clayton as a destination - a place to live, work, and play. The City has made substantial progress toward achieving this goal; from fostering major housing developments, implementing the City's first parklet, initiating a housing study, commissioning a wayfinding program, and improving city parks, the Downtown Clayton Master Plan is well under way.

HOUSING

One of the first goals presented in the Downtown Master Plan involves creating a more vibrant downtown experience by introducing additional housing options. A strong downtown residential base enlivens the streets, supports retail, and provides an additional source of revenue for Clayton businesses. Three major housing developments targeting young professionals are currently in varying stages of construction.

PARKS AND OPEN SPACE

The Downtown Clayton Master Plan also emphasizes the role of parks and open space to complement the density of a downtown urban environment. Parks and DEMOLITION OF 8500 MARYLAND

open space provide shared spaces and beautiful natural scenery. The Downtown Master Plan recommends creating a stronger connection and link between Shaw Park and downtown Clayton. In April of this year, the Clayton Century Foundation announced a \$7 million gift from the Chapman Family and Barry-Wehmiller to fund a plaza at the corner of Brentwood and Forsyth. The gift will cover the entire cost of construction as well as the cost of maintenance for a twenty year period. The plaza will serve as a pedestrian entryway providing a link between the park and downtown. The project is expected to be completed in the summer of 2017.

MAYOR'S MESSAGE

Mayor Harold J. Sanger

The national, regional and local conversations that revolve around guns and gun safety seem to have more opinions than solutions, but your Mayor and Board of Aldermen agree that efforts to prevent accidental shootings are in the best interest of the Clayton community and the St. Louis region. Not a single day seems to go by without the report of one or more shootings in the St. Louis area – whether intentional or accidental. The incidents involving children are the most heartbreaking and the media's coverage of grieving parents is haunting, considering that in many cases these tragic events could have been prevented.

Whether you agree or disagree with the mission of the National Rifle Association, one specific issue should appeal to everyone. The NRA's website states that "in a home where guns are kept, the degree of safety a child has rests squarely on the parents and gun owner ...and they must absolutely ensure that it is inaccessible to a child." We agree.

The most recent national statistics report that 1,670 minors (under 18) died by gunshot wounds and 9,718 minors were injured during 2013. It is estimated that one child under the age of 13 is killed every week, and the vast majority of incidents are the result of access to guns at home.

Do you have a gun in your home that you would prefer not to have and you don't know what to do with it? Are you concerned that your children or grandchildren will come across a gun in your home? If so, the Clayton Police Department is prepared to receive and destroy unwanted guns under our "GUN SURRENDER" program.

If you have a gun that you want to keep but wish to make it safer, the Clayton Police Department will provide you with trigger locks FREE of charge. Please see program details at www.claytonmo.gov/policeservices.

Winter Weather Tips

- Park off-street when there are two or more inches of snowfall in the forecast in order to allow snow plows to clear all snow from curb line to curb line.
- If you do park on the street, try to park as close to the curb as possible.
- Shovel your snow to the downhill traffic side of your driveway – the traffic flow side – so when the plows move down the street, the pile of snow will not be pushed back onto your driveway.
- When driving, stay back at least fifty feet from the snow plows. Vehicles traveling directly behind the plows may be difficult for the snow plow operator to see.



Resident/Business Survey Results Now Available

This summer, ETC Institute administered a survey to residents and businesses as part of the City's effort to assess citizen satisfaction with the quality of city service. The final results were presented to the Board of Aldermen in September. Clayton rated above the national average in 52 of the 53 areas that the survey assessed. The survey was also able to identify areas where improvements can be made. The highest priorities for residents and businesses were improving traffic flow and the maintenance of city streets.
