We recognize the difficult and dangerous job that we ask our Police Officers to perform every day. For this, we are deeply appreciative of all that they devote to ensuring our community is safe. We are extremely grateful for their desire to always improve and grow in the services they provide to our residents, businesses and all visitors of our community. The learning opportunities that have arisen from this incident are no exception. It is challenging, but important, that we bridge the gap between every day procedures and understanding the perspectives of those with whom we interact.

The unintended results of the July 7 incident with our Washington University students have called our community to action and invited us into a space we have not yet formally explored. We will all benefit from meaningful and inclusive conversations about race and our values as a community.

An important educational institution in our community, the School District of Clayton, has already been opening the door to these difficult conversations about race and social equity. This is another example of the next generation challenging us. We embrace and endorse their efforts and we believe, by working together to join the conversations they have already started, we can create more opportunities to build on this important work, including the way we serve everyone in our community.

### MAYOR'S MESSAGE Mayor Harold J. Sanger

This is not the article I expected to write for this issue of City Views. My intention was to write words of encouragement for everyone to show up at the polls and vote on August 7, and I hope you do.

When the St. Louis media began reporting on the "dine & dash" event at the Clayton IHOP on July 7, my email inbox quickly filled with opinions from both

residents and non-residents. The opinions ranged from full support to full condemnation of our police and Clayton leadership, and all before the facts were known.

As we go to press, the investigation of the July 7 "IHOP Event" continues. What I know for sure is that we have a highly respected, internationally certified Police Department that does a great job keeping our community safe. They have an incredibly difficult job to do and they do it in an outstanding manner every day. When the investigation has been completed, we will share what we have learned and our plans going forward.

One undisputed fact is that the group of ten 17 & 18 year old African-American teenagers that were stopped on their way to the Metro Station were not the ones responsible for the "dine & dash". They were incoming freshmen at Washington University attending a pre-first-semester session on the campus and by happenstance, left the IHOP around the same time as the "dashers".

The investigation will confirm if policies and procedures were followed, but there is more to the story. When interviewed by our Police Chief and the City Manager, it was clear that the students, as innocent bystanders, were shaken by the encounter and by how it unfolded. We have expectations about how services are delivered to the public that goes beyond just policy and procedures. This event will serve as the catalyst for us to have a dialog about uncomfortable topics and how they are dealt with in our city and region, and we welcome that conversation.

I am very sorry for what these new WU students experienced. Every situation and event gives us the opportunity to learn, grow, and build toward a better future. The Board of Aldermen and I are committed to assuring that Clayton is a safe and welcoming city, and that everyone is treated respectfully. And, we hope that these students can go back to their primary focus — being freshmen in college.

## Board of Aldermen to Consider Fiscal Year 2019 Budget

During the first week of July, City Manager Craig Owens proposed the Fiscal Year 2019 budget for the City of Clayton to the Board of Aldermen. The proposed budget includes a one year operating

budget plus two additional planning years for all funds as well as a five year Capital Improvement Plan. As proposed, the budget achieves a balanced General Fund budget, continuing this achievement from the prior years. The budget is guided by the principles of maintaining high service levels, responsiveness to the needs of residents and businesses, preservation of long-term financial stability through sound fiscal management, and well-planned capital investment to preserve infrastructure and public facilities.

The proposed budget is available for review online at www.claytonmo.gov/budget.

Residents are invited to attend the August 28 Board of Aldermen meeting where the budget will be considered, and a public hearing will be held.

# **Shaw Park Ice Rink Returns this Winter**

Outdoor ice skating has been a tradition in Clayton for nearly 60 years, and this year the tradition will continue. Though it was initially slated to be closed, Shaw Park Ice Rink will be open this winter for another regular season of skating, hockey and family fun. The Rink was originally scheduled to close for reconstruction this past spring. Due to a lack of responsive bids, the project has been delayed at least one season to revise the design which is expected to go back out to bid once edits are complete.
