

City Recognized for Performance Management Leadership

The International City/County Management Association (ICMA) has announced that the City has been recognized for its data-driven management and reporting efforts with a Certificate of Excellence in Performance Management. This is the City's ninth consecutive year to be recognized by ICMA for Performance Management Leadership.



Certificates are based on established criteria and are awarded at three levels: Achievement, Distinction, and the highest level of recognition, Excellence. Certificates of Excellence go to those who track and report key outcomes, survey residents and local government employees, incorporate data into performance dashboards or other visual communications, and foster the development of a performance culture throughout their organizations.

Clayton is among 27 jurisdictions in the country and one of two in the state of Missouri receiving the Certificate of Excellence, and one of 63 recognized overall nationwide. To learn more about the City's Performance Management, please visit **www.claytonmo.gov/performancereporting**.

Community Camera Program

Is your home or business equipped with a private video surveillance system? Have you registered your cameras with the Community Camera Program? Video surveillance is an invaluable tool when it comes to quickly apprehending and convicting criminals. Once a camera is registered, it is added to the



community camera program database, which can only be accessed by the Clayton Police Department. This database helps officers to quickly identify cameras in the area which may have captured images of suspects or a crime in progress. Registering your home or business cameras does not automatically give officers access to your surveillance system. Instead, officers will only contact you if there is a criminal incident in the vicinity of your camera and police personnel believe your video footage may assist in the investigation.

Clayton Police Body Camera Update

The Clayton Police Department has partnered with seven other municipal police departments in St. Louis County to receive a Department of Justice grant to subsidize the purchase of body worn cameras and the storage of video files. Earlier this year, the consortium of police departments conducted test and evaluations of body cameras. Panasonic's body camera was selected as the preferred body camera as a result of the field testing. Negotiations with Panasonic are taking place and the deployment of the body cameras should occur by early next year.

Public Safety is a top priority, and our police and firefighters have been actively communicating and interacting with residents and businesses about best practices to keep all of us and our belongings safe.

Investment in Parks and Recreation facilities is an ongoing process to support healthy lifestyles for residents of all ages. The Center renovation project is well underway, and the popular DeMun playground has been updated. The Shaw Park All Season Recreational Facility (now fondly referred to as SPARC) is in its final design phase and demolition of the existing Ice Rink (circa 1961) will begin. And, new property was acquired for a small pocket park on Maryland Avenue just east of the new St. Louis County Library.

Commercial Development remains strong with several projects underway. Centene is currently moving into some floors of its new tower and expects to finish the remainder of the building very soon. Construction has begun on the Clarendale, a senior living center at Clayton & Hanley, and a new AC hotel is expected to break ground this fall at 227 South Central. Additional office/retail/ residential projects are still conceptual but affirm that Clayton is a top destination for investment. With all this growth, we monitor traffic impact to ensure flow and multi-modal mobility.

Did You Know?

Since its completion in September 2012, the solar array located on top of the parking garage at the Police Station located at 10 S. Brentwood has produced over 1.1 MWh of electrical energy and avoided the production of 1.8 million pounds of carbon dioxide, 3 thousand pounds of nitrogen oxide and just under 7 thousand pounds of sulfur dioxide emissions. This is equivalent to just under 2 million car miles not driven. City Retains Highest Bond Credit Rating

Did you know that bond rating agencies assign a bond rating to each municipality seeking debt? In August, Clayton's AAA general obligation and AA+ special obligation bond ratings were reaffirmed by Standard & Poor's (S&P). S&P has issued a rating report describing the aspects of the City, which helped warrant the continued high ratings such as the City's strong economy, financial management and policies, budgetary performance and fund balances. These are the highest ratings available for any community and Clayton is one of only a handful of cities in Missouri to hold a AAA rating.


Susan Buse Ward II Alderman

On Tuesday, August 13th, the City welcomed Ward II Alderman Susan Buse to the Board of Alderman. Alderman Buse was elected Tuesday, August 6th to fill the vacant Ward II seat following our April Mayoral election.

A graduate of Washington University and University of Virginia School of Law, Susan has lived in Clayton for 25 years. Prior to her Board of Aldermen service, Susan served on the Clayton Board of Education, working in partnership with Clayton City government and serving as liaison for City sustainability and other efforts. Susan stepped off the Board of Education in 2016 to help launch the Board's newly adopted Equity Initiative. She continued this work into 2019, helping lead the District's Community Forum on issues of race and equity.

Board of Aldermen Adopt Fiscal Year 2020 Budget



In July, Interim City Manager Janet Watson proposed the Fiscal Year 2020 budget for the City of Clayton. The Mayor and Board of Aldermen held several work sessions, meetings and public hearings to review the proposed budget plan and make adjustments prior to final adoption. The budget is guided by the principals of maintaining high levels of service, responsiveness to the needs of residents and businesses, and preserving long-term financial stability through sound fiscal management. The approved budget plan predicts a small General Fund deficit, but reserves will remain healthy at 59% of annual expenditures. Overall, the budget ensures a continuation of all City services delivered in the previous year.

2020 Municipal Election Information

In accordance with the state law and the Charter of the City of Clayton, notice is given that a general municipal election shall be held in the City of Clayton, Missouri on Tuesday, April 7, 2020 for the duly qualified electors of the City to select three Aldermen, one from each ward, for a three-year term of office.



Requirements for position of Alderman (Charter, Article II, Section 3):

Section 3. An alderman shall be at least twenty-five years of age, a qualified voter of the State of Missouri, and a resident of the City of Clayton for at least two years immediately prior to his election. Aldermen elected by wards shall be residents of the wards from which they are elected. Aldermen shall hold no other remunerative position in the city government during their terms. If an alderman shall cease to be a resident of the City of Clayton or of the ward by which he was elected or shall otherwise cease to possess these qualifications, or shall be convicted of a crime involving moral turpitude, his office shall immediately become vacant.

Filing for said offices shall open at 8 a.m. and close at 5 p.m. on Tuesday, December 17, 2019, at which time the City Clerk shall receive Declarations of Candidacy, 10 N. Bemiston Avenue, Clayton, Missouri.

Thereafter, declarations will be received by the City Clerk or her designee from 8 am to 5 pm, Monday thru Friday, (excluding holidays when City Hall is officially closed) until filing closes at 5 pm, Tuesday, January 21, 2020. Names of candidates shall be listed on the ballot in the order in which they are filed.
